ORDER

The appellant has preferred 1st appeal (bearing No. PODEP/A/E/20/00020 dated 12.03.2021) against the reply/order of CPIO/East in connection with his RTI application (bearing No. PODEP/R/E/21/00137 dated 06.03.2020) with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 17/UT/RTI/FAA/SSP dated 12.03.2021 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:-

Appellant had sought certified copies of his statements recorded in complaint bearing No. 2020-03717 & 2020-12932.

COMMENTS OF CPIO/EAST: -

CPIO/East submitted that application of the appellant was received for supplying requisite information and report from SHO/PS-26 was obtained, thereafter, requisite information was denied by applying section 8(1)(h) of RTI Act as complaints in question are still under enquiry.


DECISION:-

The undersigned has gone through the contents of RTI application & appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that appellant had sought certified copies of his statements recorded in complaint bearing No. 2020-03717 & 2020-12932.

Insofar appeal is concerned, it is clear that complaints bearing No. 2020-03717 & 2020-12932 are under enquiry with Police Station Sector 26 and appellant is alleged party in these complaints. As of now, he only wants copy of his statements recorded by enquiry officer which can be furnished to the appellant. Hence, CPIO/East is hereby directed to furnish the copy of appellant's statements to him as per RTI Act.

Appeal stands disposed of.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
