appeal (bearing preferred 1 st

No. has appellant PODEP/A/E/21/00023 dated 17.03.2021) against the reply/order of CPIO/PHQ in connection with his RTI application (bearing PODEP/R/E/21/00143 dated 09.03.2020) with the contentions that requisite information was not supplied to her. The instant appeal was diarized vide No. 19/UT/RTI/FAA/SSP dated 17.03.2021 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:-

Appellant had sought copy of complete complaint file bearing No. 2013-15702 dated 27.12.2013.

COMMENTS OF CPIO/PHQ: -

CPIO/PHQ submitted that application of the appellant was received for supplying requisite information and report from HAC Branch was obtained, who reported that complaint in question - 2013-15702 has already been destroyed vide order no. 5117-20/UT/HAC dated 18.07.2018. Appellant was informed in this regard vide letter No. 38/CPIO/Hqrs/Online RTI-21, D-27 dated 16.03.23021.

DECISION:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/PHQ vis-à-vis material available on record which revealed that appellant had sought copy of complete complaint file bearing No. 2013-155702 dated 27.12.2013.

Insofar as appeal is concerned, it is clear from the reply of CPIO/PHQ that complaint in question i.e. 2013-15702 has already been destroyed vide order no. 5117-20/UT/HAC dated 18.07.2018, and not available in record. Thus, CPIO is not in position to furnish the requisite information. However, copy of order vide which said record was destroyed, can be supplied at present.

Hence, CPIO/PHQ is hereby directed to supply the copy of destroyal order, free of cost, forthwith. The instant appeal is hereby disposed of.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
