This is an order in First Appeal bearing dated 15/10/2024, preferred by of Sh. Rajender Singh Jaglan R/o 111/8-C, Shanti Nagar Manimajra Sector- 13, Chandigarh, submitted under section 19(1) of RTI Act-2005 in the office of SSP/UT-cum-FAA, which was further transferred to the office of undersigned, vide no. D-373/UT/RTI/FAA/SSP dated 16.10.2024, for part disposal at own level w.r.t. CPIO/Accounts and CPIO/PLWC.

**Facts:-**

2. Vide RTI application dated 12/09/2024, the applicant has sought information in 05 points, pertained to CPIO/Accounts and CPIO/PLWC, which are as under:-

1. पुलिस कर्मचारियों का वेल्फेयर फंड काटने के बारे सर्कुलर या आदेश की कापी दी जाए।
2. पुलिस कर्मचारियों का वेल्फेयर फंड कब कितना बढ़ाया गया है। इसके हर बार बढ़ाने का सर्कुलर या आदेश की कापी भी दी जाए।
3. विभाग वेल्फेयर फंड का इस्तेमाल या खर्च कहां कहां करता है।
4. किसके आदेश पर वेल्फेयर फंड से रकम निकाली जा सकती है।
5. अभी विभाग के पास कितना वेल्फेयर फंड है।

3. The appellant is not satisfied with the information supplied by the CPIOs against his RTI application and has filed the instant appeal mentioning therein that the information sought by the applicant vide his RTI application dated 12.09.2024 has not received in time.

4. The Comments of CPIO/Accounts and CPIO/PLWC were sought, vide No D-816/R/SP/Hqrs. dated 21.10.2024, which are as under:-

**Comments of CPIO/PLWC**


CPIO/PLWC intimated that the said RTI application was transferred by CPIO/Accounts & Procurement), vide no. vide No. 26917/RTI/CPIO/(Accts)2024/UT dated 25.09.2024, to provide part information u/s 6(3) of Right to Information Act 2005. The requisite information pertained to the Welfare Branch (PLWC) i.e. point nos. 1 to 4 were provided to the applicant within stipulated vide no. 2/DSP/PLWC,RTI-2024 Dated 16.10.2024.

**Comments of CPIO/Accounts**

CPIO/Accounts intimated that the information w.r.t. point no. 05 has already been provided to the applicant vide letter No. 107/RTI-24/CPIO/(Acct)/2024/UT/26919 dated 25.09.2024.

**DECISION**

5. I have considered the appeal filed by the appellant viz-a-viz comments of CPIO/PLWC and CPIO/Accounts. The undersigned being First Appellate Authority of CPIO/PLWC & CPIO/Accounts found that the CPIOs have provided the all information to applicant sought vide his application within stipulated time period. Therefore, no more action is required into the instant appeal. The appeal is hereby disposed off, accordingly.
