

**THE SUPERINTENDENT OF POLICE, HQs.-CUM-APPELLATE  
AUTHORITY-HQs., UNDER RIGHT TO INFORMATION ACT, 2005.**

**ORDER**

**Order on First Appeal u/s 19 RTI Act.**

This is an order on the appeal preferred by Sh. Munesh K. Singh, H.No. 2594, Sector-27-C, Chandigarh-160019 under RTI Act 2005, received in office online through RTI Request & Appeal Management Information System(RTI-MIS), bearing no. PODEP/A/E/20/00017 on 22.04.2020, against disposal of his online RTI Application by CPIO/HQs.

(2) The appellant, vide his online RTI application bearing no. PODEP/R/E/20/00103 on 06.04.2020 under RTI Act 2005, had requested to Nodal Officer-cum-CPIO/HQs. to supply him some information pertaining to some complaint made by him regarding danger to his life. The application was disposed off through online RTI portal on 20.04.2020 by supplying the information in the shape of 24 pages.

(3) The appellant, not satisfied with the manner in which his application was disposed of by CPIO/HQs., filed the instant appeal aggrieving that the CPIO has provided him totally different information.

(4) The comments of DSP-cum-CPIO/HQs. have been called for. He has reported that the appellant has filed 3 RTI applications on different dates. Information sought in these applications and replies are as:

1.	RTI application received through online bearing its Regd. No. PODEP/R/E/20/00103 dated 06/04/2020, in which he mentioned that I had submitted a complaint or intimation regarding danger of my life from Sh. Satpal, Hari Ram, Shivam, Vikas, Smt. Jyoti, Smt. Sunita and others so please provide me the all ATR - action taken report in this regard in shape of Hard copy of CP and NP or official letters along with the statement submitted by the concerned persons.	As the appellant had not mentioned complaint numbers in his RTI application, so I/C PWS was directed to supply the details/present status of complaints sought by the appellant. In response, he supplied the list of complaints which were consigned with HAC branch. Accordingly, I/C HAC was directed to supply the relevant files i.e. PW-201801177, PW-201818916 & PW-201911120. On 09/04/2020, appellant was requested through online to submit a sum of Rs. 80/- for twenty four (24) pages. After receiving the requisite fee from the appellant, the information in the shape of twenty four (24) pages has been sent to the appellant through registered post. Further, action taken report of mentioned complaints sought under RTI as well as statements of the appellant which was available in the relevant files has been provided. Besides this, no any statement is available in the relevant files except Munesh Kumar. The requisite fee of Rs. 80/- has been received through online i.e. Rs. 48/- against twenty four (24) pages (2 rupees per page) and rest of the amount i.e. Rs. 32/- received, to deliver the RTI information through registered post.
2.	Appellant filed RTI application vide ref no. 249/RTI/CAPIO/UT/PWS dated 17/02/2020 to supply the information of complaint nos. PW-201801177, PW-201818916 & PW-201911120 and the same RTI application has also been transferred to CPIO W&CSU & CPIO East accordingly by CAPIO Public	In this regard, I/C PWS was directed to furnish the detail of complaints sought by the appellant under RTI. In response, he supplied the list of complaints which were consigned with HAC branch. Accordingly, I/C HAC was directed to supply the relevant files i.e. PW-201801177, PW-201818916 & PW-201911120. After receiving the same, the appellant was informed vide no. 183/DSP/Hqrs/RTI-2020, D-253 dated 06/03/2020 to collect the information to the office of undersigned. On 13/03/2020, he visited the office of



	Window.	undersigned and collected the information in the shape of thirty (30) pages in proper receipt. The appellant was not satisfied with the reply of CPIO, so he filed an appeal before FAA vide no. D-326/RTI/SP/Hqrs/UT dated 16/03/2020 which was disposed of by your esteemed office vide no. 474-76/RTI/SP/HQs. dated 30/03/2020.
3.	Appellant filed RTI application vide ref no. 437/RTI/CAPIO/UT/PWS dated 25/03/2020 to supply the information of complaint nos. PW-201801177, PW-201818916 & PW-201911120 and the same RTI application has also been transferred to CPIO W&CSU & CPIO East accordingly by CAPIO Public Window.	The requisite information has been supplied to the appellant in the shape of twenty four (24) pages through registered post vide nos. 35/DSP/Hqrs/Online RTI-2020, D-34 & 301/DSP/Hqrs/RTI-2020 dated 15/04/2020.

(5) I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by CPIO/PHQ. The information sought by the applicant, grievances raised in the first appeal and the order/decision of the undersigned being first appellate authority is given below:

No. 183/DSP/Hqrs. /RTI-2020 D-253 Dated Chandigarh, the 06.03.2020</p> <p>Respected Sir,</p> <p>In this connection it is intimated that I received a letter vide ref 1 and 2 under which CPIO Police Headquarters U.T Chandigarh supplied me the information in 24 pages regarding my submitted online RTI ref no-3 That was totally different in nature. The concerned CPIO still not provide the required information as per submitted RTI as subject cited above, beside of that concerned CPIO forwarded me the copy of already prepared or supplied information in favor of my first RTI ref. no. 4. Moreover, CPIO wrongly charged the extra fee to me for this irrelevant information.</p>	<p>In the RTI application the appellant has given reference of a complaint regarding danger to his life to which the CPIO/HQs. had supplied the sought information. But the appellant is not satisfied with the information supplied. It is not the fault of the CPIO alone as the appellant had not pin-pointed the complaint he is referring to. He should have had mentioned the Public Window number or any other number of the complaint.</p> <p>The CPIO is directed to write a letter to the appellant, get the number of the complaint and supply the information if the enquiry on the complaint is concluded/complaint is filed. The information be given as per the provisions of RTI Act and also free of cost.</p>



	It is again my humble request to concerned authorities please provide me the required RTI information as subject cited above.
