ORDER

The appellant has preferred his 1st appeal through online RTI portal bearing registration no. PODEP/A/2019/60005 dated 02.02.2019 against the reply/order of CPIO/PHQ with the contentions that requisite information was not supplied to him. The same was diarized vide No. R-20/UT/RTI/FAA/SSP dated 02.02.2019.

Information sought vide RTI application :


The appellant vide his RTI application bearing no. PODEP/R/2019/50050 dated 03.01.2019 had sought information on 13 points with regard to complaints, RTI application and RTI appeal filed by Ms. Shaweta Sharma against Ankur Verma from 2015 to 2019.

Comments of CPIO/PHQ :

CPIO/PHQ submitted that RTI application was received through online RTI portal bearing registration no. PODEP/R/2019/50050 dated 03.01.2019. Thereafter, requisite information was obtained from I/C Public Window and Reader to SSP/UT. After that information with regard to Point No. 1 & 13 was supplied to the appellant. However, Information with regard to Point No. 2 to 10 was denied under section 8 (1) (j) of RTI Act being a third party information and appellant was informed vide No. 53/DSP/Pqrs/Online RTI-19, D-169 dated 01.02.2019.

Decision :

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/PHQ vis-à-vis material available on record which revealed that the appellant had sought information on 13 points with regard to complaints filed by Ms. Shaweta Sharma against the appellant, RTI applications and RTI appeals filed by Ms. Shaweta Sharma from 2015 to 2019.



In reply, CPIO/PHQ information supplied information with regard to Point No. 1 & 13 to the appellant. However, Information with regard to Point No. 2 to 10 was denied under section 8 (1) (j) of RTI Act being a third party information.

So far as the appeal is concerned, the contents of RTI application were perused thoroughly which revealed that appellant sought information on 13 points. The requisite information can be differentiated into two parts i.e. (1) complaints filed by Ms. Shaweta against the appellant and (2) RTI applications as well as Appeals filed by Ms. Shaweta. As far as the first part is concerned i.e. complaints filed by Ms. Shaweta against the appellant, the same is primarily related to the appellant hence, CPIO/PHQ has already supplied the requisite information to the appellant.

With respect to second part i.e. RTI applications and appeals filed by Ms. Shaweta Sharma specifically in relation to the complaints filed by her against the appellant, the part information can be supplied to the appellant i.e. number of RTI applications and appeals, memo numbers, mode of supply etc. but other personal details such as name of receiver of information with date and representatives present during summoning/hearing etc. cannot be supplied, being a personal information. Hence, the same is hereby denied u/s 8 (1) (j) of RTI Act. Moreover, appellant can visit the official websites of Chandigarh Police and Hon'ble, CIC, New Delhi for requisite information and collect the available one.

In view of above, CPIO/Hqrs is directed to supply the aforementioned information regarding the RTI applications and appeals of Ms. Shaweta Sharma as per RTI act.

With aforementioned observations, the appeal of the appellant is disposed of accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, as above, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
