

THE SUPERINTENDENT OF POLICE HQs.-CUM-APPELLATE AUTHORITY-HQs., UNDER RIGHT TO INFORMATION ACT, 2005.

Order on First Appeal u/s 19 RTI Act.

This is an order on the online appeal bearing no. PODEP/A/E/20/00020 dated 26.04.2020 preferred by Sh. Nand Lal r/o H.No. 779, HUDA quarters, Sector-19, Panchkula, Haryana under RTI Act 2005 and received in this office on 30.04.2020 through the office of SSP/UT. The appellant has filed this appeal against the disposal of his online RTI application bearing no. PODEP/R/E/00095/1 dated 25.03.2020 by CPIO/Hqrs. and no. PODEP/R/E/00095/2 dated 25.03.2020 by CPIO/Communication Wing.

- 2. The appellant, vide his application dated 26.04.2020, under RTI Act, had requested Nodal Officer(RTI) to supply him some information in 27 points pertaining to complaints made by him vide No. PW201918168, PW-201919292 and PW-201919295. Nodal Officer further transferred the said RTI application point-wise to the concerned CPIOs i.e. (Point No. 1 to 4 to CPIO/HQs, Point No. 5,6,8 to 27 to CPIO/South and Point No. 7 to CPIO/Communication Wing) to dispose of at their own level/end. The undersigned is the first appellate authority w.r.t. CPIOs/HQs., and Communication Wing only.
 - 3. The information sought by the appellant in the RTI application and the information supplied by the CPIO/HQs. and Communication Wing, are as given below:-

Information Sought in RTI application

Point No. 1 to 4 relates to CPIO/HQs.

Point No. 1) Certified copy of each & every remark recorded by the SSP, UT Chandigarh on the above complaints PW No.201918168, PW No.201919292 and 201919295, be supplied.

Point No. 2) Certified copy of each & every communication received from Home Secretary-UT and/or DGP-UT to SSP-UT pursuant to PW No.201918168, PW No.201919292 and 201919295, be supplied.

Point No. 3) Certified copy of each & every letter/communication vide which comments of any public authority/officer/official/ delinquent has been sought pursuant to PW No.201918168, PW No.201919292 and 201919295, be supplied.

Point No. 4) Copy of each & every letter/reply vide which comments of any public authority/officer/official/delinquent has been submitted pursuant to PW No.201918168, PW No.201919292 and 201919295, be supplied.

Information supplied

The requisite information is ready to be delivered in shape of eighty five (85) pages. Kindly send Rs 220/- as additional fee plus postal charges to proceed further in the matter.

Point No. 07 relates to CPIO/Communication Wing.

Point No. 7) Copy of each & every DDR registered by Police Control Room in pursuance to the call made at 100 from mobile no. 99155-74204 on 20.09.2019 with regard to dispute held at H.No 2396/B (EWS), Sector-63, Chandigarh, be supplied.

The requisite information (point No. 07) relates with Communication Wing containing 3 pages as supplied by Inspector/Communication (Admn.) is available in this office. So you are intimated to deposit the additional requisite fees of Rs 6/- to dispose off your application.

4. The comments of CPIO/HQs. and CPIO/Communication, have been called for. The Ground for Appeal, comments of the CPIOs and decision of the undersigned being first appellate authority is as under:

Further, on scrutinize of relevant files, it found that some of the information sought by the appellant relates with CPIO South Sub Division, so point no. 08 to 27 of this RTI

The demand if Rs. 6/- by CPIO Communication on 03.04.20 was unjust, illegal and erroneous as the sought information was liable to be supplied within 48 hours in view of strict terms of life & liberty of citizens for which a criminal misc. Petition was in fact pending adjudication before the Hon'ble Punjab & Haryana High Court, Chandigarh. However finding no other alternative or remedy the sought fee was deposited online under protest. The information sought was supplied by the CPIO after the lapse of more than 48 hours. The three supplied pages were unattested. The CPIO may be directed to supply all 03 pages duly attested besides order for refund of Rs. 6/- being charged against the provisions of the RTI Act, 2005.	From the perusal of contents of PDF attached appeal, the appellant has not mentioned about any deny of information relates with this wing, as the requisite information of Point No. 07 had already been supplied to him by this office. Hence, there is no delaying/delay in supplying of information to the applicant by this office.	The contents of the RTI application of the appellant do not fall under the provision of Section 7(1) i.e. supplying of information within 48 hours concerning life & liberty of the appellant. The appellant has provided the information within due period. However the CPIO has failed to provide the attested copies of the information hence he is directed to supply the information duly attested

application has been transferred to CPIO South Sub Division under the provision of RTI Act.

within 7 days of issue of this order. The information be provided free of cost.

The appeal is disposed of accordingly.

The appellant, if not satisfied with the disposal of appeal in the manner as above can file second appeal with the Hon'ble Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munrika, New Delhi-110067 within a period of 90 days.
