



**THE SUPERINTENDENT OF POLICE HQs.-CUM-APPELLATE AUTHORITY-TRAINING,  
UNDER RIGHT TO INFORMATION ACT, 2005.**

**Order on First Appeal u/s 19 RTI Act.**

This is an order on the online First Appeal bearing no. PODEP/A/E/20/00021 on 05.05.2020 preferred by Ms. Neetu R/o 144, VPO Jarout, Teh. Dera Bassi, SAS Nagar, Mohali, Punjab under RTI Act 2005, received in office online through RTI Request & Appeal Management Information System (RTI-MIS), against disposal of her online RTI Application bearing no. PODEP/R/E/20/00110 dated 11.04.2020 by CPIO/Training.

1. The appellant, vide her online RTI application under RTI Act 2005, had requested to Nodal Officer of RTI/PHQs to supply her some information pertaining to recruitment of 520 constables in Chandigarh Police in 06 points. Nodal Officer further transferred the RTI application to CPIO/Training on 13.04.2020 and the same was disposed of by CPIO/Training.

2. The appellant, not satisfied with the manner in which her application was disposed of by CPIO/Training and filed the instant appeal alleging that she may be provided the information.

3. The comments of DSP-cum-CPIO/Training have been called for. She has reported that the appellant had filed an online RTI application/request on 11.04.2020 vide No. PODEP/R/E/20/00110 to supply the information regarding the CBT exam of 520 constables. The application was sent to the In-charge Recruitment Cell (CAPIO) for reply on 13.04.2020 as no record regarding the CBT exam was with her office. In-charge Recruitment Cell replied on 15.04.2020 that RTI application is third party information. So, it may be denied under section 8(1) (j) of the Right to information Act-2005. The applicant has sought the information of other candidate Rekha Rani (209433) exam pdf (i.e. third party). Hence the desire/sought information has been denied under section 8(1) (j) of the Right to information Act-2005.

4. I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by CPIO/Training. The appellant, through RTI application, had sought information relating to CBT exam of 520 constables recently conducted by Chandigarh Police. The information sought by the appellant, supplied by the CPIO, grievance of the appellant and the order/decision of the undersigned being first appellate authority is given below:
