

THE SUPERINTENDENT OF POLICE HQs.-CUM-APPELLATE AUTHORITY-ESTABLISHMENT, UNDER RIGHT TO INFORMATION ACT, 2005.

Order on First Appeal u/s 19 RTI Act.

This is an order on the appeal dated 11.10.2019 preferred by Sh. Jagjeet Singh r/o H.N. 5080/2, Modern Housing Complex, Chandigarh under RTI Act 2005 and received in this office on 14.10.2019. The appellant has filed this appeal against the disposal of his RTI application dated 2.09.2019 by CPIO/Establishment (PHQ).

- 1. The appellant, vide his application dated 02.09.2019, under RTI Act, had requested CPIO/Estt. to supply him some information pertaining to sensitive posts and public dealing posts in Chandigarh Police. CPIO disposed off the RTI application vide No.211/RTI-19/CPIO(Estt)/UT/39811 on 07.10.2019.
- 2. The comments of DSP-cum-CPIO/Estt. have been called for. He has reported that information has already been provided to the applicant as per record available in the office. He also stated that there was no criteria available with the office to define sensitive posts.
- 3. I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments of CPIO/Estt. The appellant was contacted telephonically on 22.10.19 and was offered personal hearing. He declined the same and replied that he was satisfied if his RTI Appeal was disposed of on merit. The information sought by the appellant, supplied by the CPIO, grievance of the appellant and the order/decision of the undersigned being first appellate authority is given below:
