**ORDER**

**Order on First Appeal u/s 19 RTI Act.**


This is an order on an appeal bearing no. RTI Appeal-01/R/SP/HQs. dated 05.01.2022, preferred by Sh. Pardeep Sharma R/o # 3032, Sector- 35D, Chandigarh under RTI Act 2005 through e-mail dated 30.11.2021, against the disposal of his RTI Application, vide memo No. RTI-R-50/PEB Br. Dated 07.11.2021.

(2) The appellant, vide an email dated 14.10.2021 had submitted his application under RTI Act 2005, had requested DGP/Chandigarh & SSP/UT Chandigarh to supply him some information on 06 points in connection with his false implications in FIR No. 76 Dated 10.03.2016 PS-IA, Chandigarh. Incharge Public Window (PHQ) cum-CAPIO/PHQ has transferred the application to CPIO/Communication, CPIO/PCR, CPIO/East, CPIO/PEB, CPIO/Estt and CPIO/South vide No. 1046/RTI/CAPIO(PHQ)/UT/PWS Dated 27.10.2021. The appellant not satisfied with the information supplied to him by CPIO/PEB, has filled instant appeal aggrieving that the CPIO, vide Memo No. RTI-R-50/PEB Br. Dated 07.11.2021, has denied the information u/s 8 (1) of RTI Act being 3<sup>rd</sup> party information. The undersigned is the First Appellate Authority in respect of CPIO/PEB branch. The comments of CPIO/PEB has been called for.

(3) I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by CPIO/PEB. The appellant, through his RTI application, had sought information in 06 points, connection with his false implications in FIR No. 76 Dated 10.03.2016 PS-IA, Chandigarh. However, the RTI application was transferred by Incharge Public Window (PHQ) cum-CAPIO/PHQ to CPIO/PEB for supplying part information on point No. 04 i.e. *"All certified copies of Paramjit Kaur Sekhon Inspector Police transfer to Police Lines"*. The information sought by the appellant, supplied by the CPIO, grievance of the appellant and the order/decision of the undersigned being first appellate authority is given below:-

<b>Point No.4</b> All certified copies of Paramjit Kaur Sekhon Inspector Police transfer to Police Lines and inquiry against her conducted on code of conduct or breach of service rules.  <b>(for part information related to transfers)</b>	<b>Point No.4</b> The sought information is the personal information of individual which is not in larger public interest. Hence the sought information denied U/s 8 (1) (j) of RTI Act 2005 being 3rd Party information.	As a special case I request you that Paramjeet Kaur Sekhon Inspector is a public servant and each document maintained as public records by Chandigarh Police as public documents not personal documents.	The undersigned being first appellate authority do not agree with the CPIO/PEB. He is directed to provide transfer orders to Police lines as sought in the RTI application by the appellant.

The appellant, if not satisfied with the disposal of appeal in the manner as above can file second appeal to the Hon'ble Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munrika, New Delhi-110067 within a period of 90 days.
