ORDER

The appellant has preferred his 1st appeal dated 28.11.2024 against the disposal of his RTI application dated 14.11.2024 by concerned CPIO/North-East with the contentions that requisite information was not provided to him.

Information sought vide RTI application :-

The appellant vide his RTI application had sought information on 02 points i.e. attendance record of SI Sharminder Singh 1204/CHG of PS-Mauli Jagran and record of vehicle challans made by SI Sharminder Singh along with photos of violations.

COMMENTS OF CPIO/North-East:-

CPIO/North-East vide his comments submitted that RTI application of the appellant was received in his office to supply the information. Thereafter, requisite information was obtained from SHO-Mauli Jagran who reported that sought information is personal in nature and no larger public interest would be served by disclosing the same. Hence, the same was denied to the appellant as per the provisions of section 8(1) (j) of RTI Act; 2005 and applicant was apprised, accordingly.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/North-East vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought information on 02 points i.e. attendance record of SI Sharminder Singh 1204/CHG of PS-Mauli Jagran and record of vehicle challans made by SI Sharminder Singh along with photos of violations.

In reply, CPIO/North-East denied the requisite information to the appellant as per the provisions of section 8 (1) (j) of RTI Act.

Insofar appeal is concerned, information regarding point no. 1(attendance record of SI Sharminder Singh 1204/CHG of PS-Mauli Jagran), CPIO/South has

appropriately denied the same to the appellant as no larger public interest would be served by disclosing the same. Hence, no action is required on this point.

Information on point no. 02 i.e. record of vehicle challans made by SI Sharminder Singh along with photos of violations. In this regard, CPIO/South has denied the sought information to the appellant. However, only the figures of the challan made by SI Sharminder Singh 1204/CHG of period 2021-2024 can be provided. Therefore, CPIO/North-East is hereby directed to provide the data in figures only to the applicant.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
