ORDER

The appellant has preferred his online 1st appeal (bearing registration no. PODEP/A/E/20/00099 dated 12.12.2020) against the reply/order of CPIO/PHQ in connection with his online RTI application (bearing registration no. PODEP/R/E/20/000581 dated 21.11.2020) with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide no. 144/UT/RTI/FAA/SSP dated 14.12.2020 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:-

The appellant had sought information on 12 points on various issues pertaining to complaint No. 2020-15541 & 2020-18889.

COMMENTS OF CPIO/PHQ: -

CPIO/PHQ submitted that online RTI application of the appellant was received online for obtaining information on 12 points

on pertaining to complaint No. 2020-15541 & 2020-18889. Thereafter, report from Police Complaint Cell (PCC) was obtained regarding complainant No. 2020-18889 who informed that complaint in question is still under enquiry; therefore, the same cannot be supplied at that stage. Moreover, information (containing 5 pages) pertaining to complaint No. 2020-15541 was furnished to the appellant vide No. 181/DSP/Hqrs/Online RTI-2020, D-173 dated 02.12.2020.

DECISION :-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/PHQ vis-à-vis material available on record which revealed that appellant had sought information on 12 points on various issues pertaining to complaint No. 2020-15541 & 2020-18889.

Insofar appeal is concerned, it is clear that complaint bearing No. 2020-15541 is consigned with HAC branch after completion of enquiry and CPIO/PHQ has already supplied the appellant information containing 5 pages, even though CPIO had supplied the information, he is directed to again go through the relevant enquiry file and supply the available remaining information, if any.

Information pertaining to complaint bearing No. 2020-18889 is still under consideration for finalizing and the requisite information cannot be supplied u/s 8 (1) (h) of RTI Act at this stage. Even after that CPIO/PHQ is hereby directed that as and when the aforementioned enquiry is finalized, the same be supplied to the appellant being complainant.

Moreover, information pertaining to point No. 4 is personal information of Mr. Avtar Singh, thus, CPIO/PHQ is hereby directed to follow the provisions of section 11 of RTI Act.
