ORDER

The appellant has preferred his 1st appeal dated 05.12.2024 against the disposal of his RTI application dated 22.10.2024 by CPIO/Admn with the contentions that requisite information was not provided to him.

Information sought vide RTI application :-

The appellant vide his RTI application had sought information on 02 points i.e. copy of complaint no PW-2022-12164 and copy of complaint no. PW-2018-07792.

COMMENTS OF CPIO/Hqrs:-

CPIO/Hqrs vide his comments submitted that RTI application of the appellant was received in his office to supply the information. Thereafter, requisite information was obtained from concerned I/C HAc who reported that complaints upto year 2019 has already been destroyed in year 2023 vide no. 6552-6660/UT/HAC dated 19.09.2023 and applicant was apprised vide letter no. 375/CPIO/Hqrs/RTI-2024, D-538 dated 09.07.2024.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Hqrs vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought information on 02 points i.e. copy of complaint no PW-2022-12164 and copy of complaint no. PW-2018-07792.

In reply, CPIO/Hqrs has informed the appellant that complaints in question have already been destroyed.

Now as far as appeal is concerned, CPIO/Hqrs has already apprised the appellant that complaints in question have already been destroyed. However, appellant is not satisfied with the provided information and has preferred 1st appeal. Therefore, considering the contentions of the applicant, CPIO/Hqrs is hereby directed to provide

the copy of orders vide which complaints were destroyed to the appellant as per the provisions of RTI Act.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
