ORDER

The appellant has preferred 1st appeal dated 16.02.2023 against the disposal of his RTI application dated 21.01.2023 by CPIO/Central with the contentions that reply of CPIO is not satisfactory.

Information sought vide RTI application :-

The appellant vide his RTI bearing dated 21.01.2023 had sought certified copy of complaint filed by Ms. Preeti D/o Sh. Ved Parkash R/o H. No. 2190, Sector 23 C, Chandigarh against him in PP Sector 22 on dated 07.01.2023.

COMMENTS OF CPIO/Central:-

CPIO/Central vide his comments submitted that RTI application of the appellant was received in his office on 21.01.2023 to supply the certified copy of complaint filed by Ms. Preeti D/o Sh. Ved Parkash R/o H. No. 2190, Sector 23 C, Chandigarh against him in PP Sector 22 on dated 07.01.2023. Accordingly, a report was obtained from SHO PS Sector 17 and the requisite information was denied to the appellant u/s 8(1)(h) of RTI act as the complaint in question was under enquiry at that time. The appellant was informed accordingly vide letter No. 17/RTI-23/CPIO-Central/UT dated 03.02.2023.

DECISION:-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that CPIO/Central after obtaining report from SHO PS 17, denied the requisite information to the appellant u/s 8(1)(h) of RTI Act as the complaint filed by Ms. Preeti D/o Sh. Ved Parkash R/o H. No. 2190, Sector 23 C, Chandigarh against the appellant on dated 07.01.2023 was under enquiry at that time.

However, vide his letter dated 22.02.2023 addressed to the undersigned, appellant requested that he does not want to process his 1st appeal dated 15.02.2023 and the same may be treated as "withdrawn".

Accordingly, instant appeal is hereby filed as "withdrawn".

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
