ORDER

* * * * *

The appellant has preferred 1st appeal against the reply/order of CPIO/South & East in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 24/UT/RTI/FAA/SSP dated 30.03.2021 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:-

Appellant had sought information on 06 points with regard to ASI Parmod Kumar No. 1057/CHG i.e. certified copies of moment registered dated 10.03.2016, detail of FIR uploaded or not uploaded on website, detail of cases handled by him etc.

COMMENTS OF CPIO/EAST: -

CPIO/East submitted that application of the appellant was received through CPIO/PHQ vide Public Window No. 216/RTI/

CAPIO/(PHQ)/UT/PWS dated 04.03.2021 for supplying requisite information. After obtaining the requisite information from SHO/Ind. Area, requisite information on point No. 1, 2 & 5 was denied u/s 8(1)(h) of RTI Act. Point no. 3 was not related with it. With regard to point no. 4 & 6, was supplied to the appellant.

COMMENTS OF CPIO/SOUTH: -

CPIO/South submitted that application of the appellant was received through CAPIO/PHQ vide Public Window No. 216/RTI/CAPIO/(PHQ)/ UT/PWS dated 04.03.2021 for supplying requisite information. After obtaining the requisite information from All SHOs, appellant was informed that point No. 1 to 4 not related with it. With regard to point no. 4, it was informed that 04 cases were handled by SI Parmod Kumar No. 1057/CHG during his tenure of posting in PS-36.

DECISION:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/South & East vis-à-vis material available on record which revealed that appellant had information on 06 points with regard to ASI Parmod Kumar No. 1057/CHG i.e. certified copies of moment registered dated 10.03.2016, detail of FIR uploaded or not uploaded on website, detail of cases handled by him etc.

Whereas, RTI application was also dealt by CPIO/EOW, PEB, therefore, instant appeal was transferred to FAA of concerned CPIOs vide letter No. D-86/UT/RTI/RAA/SSP dated 12.04.2021 for deciding at their own end.

As far as the instant appeal is concerned with this FAA, appellant has sought information relating to ASI Parmod Kumar No. 1075 and CPIO/East had supplied the information related to point No. 4 and remaining information on point No. 1, 2 & 5 was denied by applying section 8(1)(h) of RTI

Act. Whereas, appellant has not asked specific information on point No. 1 & 2 relating to any case or incident/spot dated 10.03.2016, therefore, CPIO/East is hereby directed to ask for appellant about any specific DDR entry or spot/incident which he wants to obtain, and accordingly, if available, be supplied the same.

With regard to point No. 5 & 6, CPIO/East is directed to supply the figure of cases handled by ASI Parmod Kumar and also supply the copy of Duty Register (Chitha of PS-I/A) for dated 10.03.2016.

Whereas, CPIO/South has submitted that only point No. 5 relates to him and the same has already been supplied to the appellant. It is clear that as of now, no information is left out on the part of CPIO/South for supplying to appellant. Hence, instant appeal stands disposed of with the above directions as far as this FAA is concerned.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
