This is an order in online First Appeal bearing no. PODEP/A/E/23/00131 dated 14/12/2023, preferred by of Sh. Shubham R/o VPO- Humayunpur, District- Rohtak, Haryana under RTI Act 2005, received in the office through RTI Request & Appeal Management Information System (RTI-MIS), against the disposal of his online RTI Application bearing No. PODEP/R/E/23/00922 dated 20/10/2023 by CPIO/Establishment.

**Facts:-**

2. Vide RTI application dated 20/10/2023, the appellant had sought information w.r.t. recruitment of constable in Chandigarh Police (executive) 2023, which is as under :-

*"I request you to provide me the rank-wise list of all male candidates of unreserved category with their respective marks and age whose physical test is qualified in Chandigarh Police Constable (executive) recruitment 2023".*


The said RTI application was dealt by CPIO/Establishment and same was disposed of vide no. 302/RTI-23/CPIO/Estt. 45294 dated 10.11.2023.

3. The appellant, is not satisfied with the information supplied by the CPIO/Establishment against his RTI application and has filed the instant mentioning therein that *"I request you to provide me the marks of all the male candidates who have cleared the physical examination of Chandigarh Police Constable executive 2023 with their respective category and age. I request you to provide me the data in the format as shown below in the supporting document."*

4. The Comments in this appeal were sought from DSP/Hqrs-cum-CPIO/Establishment, who intimated that the appellant vide his RTI application had requested to supply the final merit list of male unreserved category with marks and age of constable recruitment 2023 in Chandigarh Police. As per the reports of the concerned branch i.e. E-2, the appellant has been advised to visit the official website of Chandigarh Police, vide office letter no. 302/RTI-23/CPIO/Estt. 45294 dated 10.11.2023.

### DECISION

5. I have considered the appeal filed by the appellant viz-a-viz comments of DSP/HQs-cum-CPIO/Establishment. The undersigned being First Appellant Authority found that the CPIO has already supplied the link of Chandigarh Police website to the applicant to get the information sought in the RTI application. Therefore, no more action is required in the matter. The appeal is hereby disposed of.
