**ORDER**

The appellant has preferred his online 1<sup>st</sup> appeal bearing no. PODEP/A/E/24/00021 dated 16.03.2024 against the disposal of his online RTI application bearing no. PODEP/R/E/24/00099 dated 12.02.2024 by CPIO/Hqrs with the contentions that requisite information was not provided to him.

**Information sought vide RTI application :-**

The appellant vide his RTI application dated 12.02.2024 had sought information on 04 points regarding Complaint No. PW-202123657 i.e. whatsapp numbers associated with the closure of the complaint, all documents related with whatsapp number, details of individuals associated with whatsapp number and specific IPC section under which complaint has been filed on whatsapp request.

**COMMENTS OF CPIO/Hqrs:-**

CPIO/Hqrs vide his comments submitted that RTI application of the appellant was received in his office to supply the information. Thereafter, requisite information was obtained from I/C HAC and appellant was requested to visit the office of the undersigned to inspect the relevant file and collect the same. Appellant was appraised about the same vide letter no. 31/CPIO/Hqrs/Online RTI-24, D-31 dated 21.02.2024. However, appellant is yet to visit the office of the undersigned to collect the sought information.

**DECISION :-**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Hqrs. vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought information on 04 points regarding Complaint No. PW-202123657 i.e. whatsapp numbers associated with the

closure of the complaint, all documents related with whatsapp number, details of individuals associated with whatsapp number and specific IPC section under which complaint has been filed on whatsapp request.

In reply, CPIO/Hqrs has requested the appellant to visit his office to collect the requisite information after inspecting the relevant file.

Now as far as the appeal is concerned, to achieve the objective of the RTI Act and for the satisfaction of the appellant, appellant is hereby again requested to visit the office of the CPIO/Hqrs to inspect the file and collect the requisite information as per the RTI Act.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
