Order on First Appeal u/s 19 RTI Act.

This is an order on an online First Appeal bearing no. PODEP/A/E/25/00022 dated 26/02/2025, preferred by Sh. Satish Kumar R/o # 4255, Sector-46 D, Chandigarh, under RTI Act 2005, received in the office through online RTI Request & Appeal Management Information System (RTI-MIS), against the disposal of his online RTI Application bearing No. PODEP/R/E/25/00002 dated 01/01/2025 by CPIO/Communication.

- (2) The appellant, vide his application dated 01/01/2025 under RTI Act 2005, had requested DSP-cum-CPIO/Communication to supply information in 06 points w.r.t. Communication Wing. CPIO/Communication disposed off his RTI application, vide No. RTI-01/DSP/CPIO/Communication/UT dated 24/01/2025.
- (3) The appellant, not satisfied with the information supplied by the CPIO against his RTI application, has filed the instant online appeal to provide complete information.
- (4) Comments of CPIOs have been called for. I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by CPIO. The information sought by the appellant, supplied by the CPIO and the order/decision of the undersigned being first appellate authority is given below:-
