**O R D E R**

The appellant has preferred 1<sup>st</sup> appeal against the reply/order of CPIO/Central in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 139/UT/RTI/FAA/SSP dated 08.12.2021 for further proceeding under RTI Act.

**INFORMATION SOUGHT IN RTI APPLICATION:-**

Appellant had sought information in connection with DDR No. 09 dated 07.10.2020 lodged at PS- Sarangpur i.e. inquest proceeding of deceased Monu.

**COMMENTS OF CPIO/Central: -**

CPIO/Central submitted that application of the appellant was received online for supplying requisite information. After obtaining the requisite information from SHO-Sarangpur, requisite information was denied to the applicant as DDR No. 09 is not related to inquest proceeding of Monu. Appellant has been apprised vide memo no. 365/CPIO/South dated 26.10.2021.

**DECISION:-**

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that appellant had sought information in connection with DDR No. 09 dated 07.10.2020 lodged at PS- Sarangpur i.e. inquest proceeding of deceased Monu.

Insofar as appeal is concerned, complainant has sought information regarding DDR No. 09 dated 07.10.2020 regarding inquest proceeding of deceased Monu. From the reply of CPIO/Central it is clear that the said DDR is not related

with inquest proceedings of deceased Monu, therefore; CPIO/Central has appropriately denied requisite information to the applicant as sought information is not related with her and no larger public interest can be served by disclosing the information. Thus CPIO has appropriately denied the requisite information. Appeal stands disposed of, accordingly

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
