ORDER

The appellant has preferred 1st appeal against the reply/ order of CPIO/Central in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 27/UT/RTI/FAA/SSP dated 19.04.2021 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:-

The appellant had sought information on 02 points pertaining to FIR No. 592 dated 04.12.2007 & FIR No. 593 dated 04.12.2007 i.e. copy of FIR & charge-sheet.

COMMENTS OF CPIO/CENTRAL: -

CPIO/Central submitted that appellant has sought information for supplying requisite information. After obtaining report from SHO/PS-17, two copies of FIR No. 592 dated 04.12.2007 & FIR No. 593 dated 04.12.2007 was provided but copy of charge-sheet was denied u/s 8(1)(j) of RTI Act being a

personal information and moreover, appellant is neither complainant nor alleged party.

DECISION:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that appellant had sought information on 02 points pertaining to FIR No. 592 dated 04.12.2007 & FIR No. 593 dated 04.12.2007 i.e. copies of FIRs & charge-sheets.

Insofar appeal is concerned, it is clear that copies of above FIRs have already been provided by CPIO/Central. As far as charge-sheet is concerned, it is clear from the reply of CPIO/Central that appellant is not related with these cases i.e. neither complainant nor alleged. Moreover, no larger public interest is shown which can be achieved by disclosing such personal information of individuals therefore, CPIO/Central had appropriately applied section 8(1) (j) of RTI Act and denied the requisite information to the appellant.

However, in the spirit of RTI Act, CPIO/Central is hereby directed to inform the appellant about the current status of above FIRs. With these observations, the instant appeal is hereby disposed of.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
