ORDER

The appellant has preferred her 1st appeal dated 17.02.2025 against the disposal of her RTI application dated 24.01.2025 by CPIO/Admn with the contentions that requisite information was not provided to her.

Information sought vide RTI application :-

The appellant vide her RTI application had sought copy of complaint and action taken on complaints no. ICMS/2024/030561 & ICMS/2024/017223.

COMMENTS OF CPIO/Admn:-

CPIO/Admn vide his comments submitted that RTI application of the appellant was received in his office to supply the information. Thereafter, requisite information was obtained from concerned I/C CRU who reported that complaints in question are under enquiry. Hence, sought information was denied to the appellant as per the provisions of section 8 (1) (h) of RTI Act and applicant was apprised vide letter no. 68/RTI/DSP/Admn dated 31.01.2025.

DECISION:-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Admn vis-à-vis material available on record which revealed that the appellant vide her RTI application had sought copy of complaint and action taken on complaints no. ICMS/2024/030561 & ICMS/2024/017223.

In reply, CPIO/Admn has denied the requisite information to the applicant, as per the provisions of section 8 (1) (h) of RTI Act.

Now as far as appeal is concerned, CPIO/Admn has appropriately disposed of the RTI application. Moreover, complaint in question is still under consideration. Therefore, requisite information cannot be provided at this stage also. However, copy of complaint can be provided to the applicant, which will not hamper the

process of enquiry. Therfore, CPIO/Admn is hereby directed to provide the copyof complaint strictly as per the provisions of RTI Act.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of her appeal, she can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
