ORDER

The appellant has preferred 1st appeal dated 09.12.2024 against the disposal of his RTI application dated 10.11.2024 by CPIO/South & East with the contentions that requisite information was not provided to him.

Information sought vide RTI application :-

The appellant vide his RTI application has sought information on 03 points i.e. certified copy of any complaint filed by Ms. Jyoti against Mr. Munesh Singh and his family, certified copies of any MLCs in regard with point no.1 and copy of all police complaints involving Mr. Munesh Singh and his family.

COMMENTS OF CPIO/South:-

CPIO/South vide his comments submitted that RTI application was received in his office to obtain the requisite information. Thereafter, requisite information was obtained from SHO PS-31 who reported that no complaint/FIR/DDR has been found registered against Mr. Munesh Singh and his family and the same was provided to the applicant vide no. 287/RTI-24/CPIO-South dated 22.11.2024.

COMMENTS OF CPIO/East:-

CPIO/East vide his comments submitted that RTI application was received in his office to obtain the requisite information. Thereafter, requisite information was obtained from SHO PS-26 who reported that no complaint/FIR/DDR has been found registered against Mr. Munesh Singh and his family except for DDR No. 12 which has already been provided to the appellant and the same was provided to the applicant vide no. 212-RTI/CPIO/East dated 12.11.2024.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/South & East vis-à-vis material available on record which revealed that the appellant vide his RTI application has sought information on 03 points i.e. certified copy of any complaint filed by Ms. Jyoti against Mr. Munesh Singh and his family, certified copies of any


MLCs in regard with point no.1 and copy of all police complaints involving Mr. Munesh Singh and his family.

In reply CPIO/South & East has informed the appellant that no FIR/Complaint/DDR has been found registered against Mr. Munesh and his family.

Now as far as the appeal is concerned, CPIO/South & East has appropriately disposed of the RTI application of the appellant as no such FIR/Complaint/DDR has been found registered except for DDR no. 12 dated 08.10.2016, which was exempted by appellant in his RTI application. Hence, no more action is required to be taken on this instant 1st appeal.


With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
