ORDER

The appellant has preferred 1st appeal (bearing No. PODEP/A/E/21/00032 dated 20.04.2021) against the reply/order of CPIO/PHQ in connection with his RTI application (bearing No. PODEP/R/E/21/000183/1 dated 27.03.2020) with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 29/UT/RTI/FAA/SSP dated 20.04.2021 for further proceeding under RTI Act.

## INFORMATION SOUGHT IN RTI APPLICATION:-

Appellant had sought status and action taken report pertaining to C-571/UT/CRU dated 10.11.2020, C-775/UT/CRU dated 12.11.2020.

## COMMENTS OF CPIO/PHQ: -

CPIO/PHQ submitted that application of the appellant was received online for supplying requisite information. After obtaining the requisite

information from Reader to SSP/UT, requisite information was denied u/s 8(1)(h)of RTI Act as complaints in question are still under consideration.

## DECISION:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/PHQ vis-à-vis material available on record which revealed that appellant had sought status and action taken report pertaining to C-571/UT/CRU dated 10.11.2020, C-775/UT/CRU dated 12.11.2020.

Insofar as appeal is concerned, it is clear that complaints in question i.e. C-571/UT/CRU dated 10.11.2020, C-775/UT/CRU dated 12.11.2020 are still under consideration, therefore, requisite information cannot be supplied at this stage, hence, CPIO/PHQ had appropriately denied the requisite information u/s 8(1)(h) of RTI Act. Thus, appeal stands disposed of.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
