ORDER

The appellant has preferred 1st appeal against the reply/order of CPIO/East in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 28/UT/RTI/FAA/SSP dated 28.03.2022 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:-

The appellant had sought information on 04 points pertaining to complaints filed by him & Action Taken Reports, leaves availed by the Investigating/Enquiry Officer, copies of instructions, rules by which investigating officer can close the matter by whatsapp letters etc.

COMMENTS OF CPIO/East: -

CPIO/East submitted that after obtaining report from SHO/PS-26, point wise reply was supplied to appellant vide memo no. 39-RTI/CPIO/East/Dated, Chandigarh, the: 24.02.2022. Moreover, information related to point no. 02 was denied u/s 8(1)(j) of RTI act as the same was a personal information of concerned officials i.e. L/ASI Babita and HC Rajesh Kumar.

DECISION:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/East vis-à-vis material available on record which revealed that appellant has preferred this appeal with respect to point no. 02 only i.e. details of leave availed by the I.O. during the investigation of complaint and name of officer who was assigned complaints in absence of I.O.

Insofar appeal is concerned, it is clear that no larger public interest can be achieved by disclosing such personal information of individuals, therefore, CPIO/East has appropriately denied the sought information u/s 8 (1) (j) of RTI Act and no other I.O. was assigned to deal with the complaints of appellant during their leave period. Hence, no more action is required in the instant appeal. Appeal stand disposed off, accordingly.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
