ORDER

The appellant has preferred 1st appeal dated 21.02.2023 against the disposal of his RTI application dated 22.01.2023 by CPIO/South with the contentions that he has not been provided information with regard to point No. 02 of his RTI application.

Information sought vide RTI application :-

The appellant vide his RTI application dated 22.01.2023 had sought information on 02 points :-

- Could you please provide public or ICMS reference number for both PMO complaints (GOVCC/E/2021/00796 dated 26.08.2021 & GOVCC/E/2022/00597 dated 12.08.2022) please.
- 2) Complaint register with Chandigarh Police emergency helpline reference number 185774 dated 26.08.2021. Please provide case closure copy.

COMMENTS OF CPIO/South :-

CPIO/South vide his comments submitted that RTI application of the appellant was received in his office through online RTI portal vide No. PODEP/R/E/23/00063 dated 22.01.2023. Thereafter, requisite information was obtained from quarters concerned and the appellant was informed vide letter no. 26/RTI-23/CPIO/South dated 18.02.2023 that as per record of South Sub Division as well as online ICMS portal, both PMO complaints bearing Nos. GOVCC/E/2021/00796 dated 26.08.2021 & GOVCC/E/2022/00597 dated 12.08.2022 were registered vide Nos. 2021-20560 dated 13.09.2021 and ICMS/2022/006276 dated 17.08.2022 respectively and DDR No. 45 dated 26.08.2021, DDR No. 60 dated 26.08.2021 and DDR No. 61 dated 02.02.2023 were lodged in PS Sector 34 regarding action taken on emergency helpline reference number 185774 dated 26.08.2021. So, available information has already been supplied to the appellant.

DECISION:-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that the appellant had sought information on 02 points regarding PMO complaints bearing nos. GOVCC/E/2021/00796 dated 26.08.2021 & GOVCC/E/2022/00597 dated 12.08.2022 and complaint register with Chandigarh Police emergency helpline reference number 185774 dated 26.08.2021.

In reply, CPIO/South informed the appellant that both PMO complaints bearing Nos. GOVCC/E/2021/00796 dated 26.08.2021 & GOVCC/E/2022/00597 dated 12.08.2022 were registered vide Nos. 2021-20560 dated 13.09.2021 and ICMS/2022/006276 dated 17.08.2022 respectively and DDR No. 45 dated 26.08.2021, DDR No. 60 dated 26.08.2021 and DDR No. 61 dated 02.02.2023 were lodged in PS Sector 34 regarding action taken on emergency helpline reference number 185774 dated 26.08.2021.

In view of above, it clearly evident that available information has already been supplied to the appellant, so, no more action is required to be taken in the matter. However, for the satisfaction of the appellant, CPIO/South is hereby directed to supply the copies of relevant DDRs of point no. 02 to the appellant again as per RTI Act.

With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
