ORDER

The appellant has preferred 1st appeal (bearing No. PODEP/A/E/21/00033 dated 20.04.2021) against the reply/order of CPIO/East in connection with his RTI application (bearing No. PODEP/R/E/21/000199 dated 06.04.2020) with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 30/UT/RTI/FAA/SSP dated 20.04.2021 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:-

Appellant had sought information on 06 points pertaining to complaint bearing No. 202-04903 i.e. action taken report, copy of statements, summons and name of enquiry officer.

COMMENTS OF CPIO/EAST: -

CPIO/East submitted that application of the appellant was received online for supplying requisite information. Thereafter, report from SHO/PS-26 was obtained and appellant was informed that complaint bearing No. 2021-04903 was under enquiry, therefore, requisite information was denied

u/s 8(1)(h) of RTI Act. As of now, said complaint was sent to W/SSP/UT Chandigarh for finalizing the same.

DECISION:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/East vis-à-vis material available on record which revealed that appellant had sought information on 06 points pertaining to complaint bearing No. 2021-04903 i.e. action taken report, copy of statements, summons and name of enquiry officer.

Insofar as appeal is concerned, it is clear that complaints in question i.e. 2021-04903 is still under consideration, therefore, requisite information cannot be supplied at this stage, hence, CPIO/South had appropriately denied the requisite information u/s 8(1)(h) of RTI Act.

However, name of Enquiry Officer can be supplied to the appellant, accordingly, this appeal is hereby disposed of with the direction to CPIO/East to inform the name of Enquiry Officer to appellant.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
