### **ORDER**

The appellant has preferred 1<sup>st</sup> appeal on 27.02.2023, received on 28.02.2023 against the disposal of her RTI application dated 12.02.2023 by CPIO/Hqrs with the contentions that case FIR was not registered on his complaint and close her RTI applications without taking action against culprits and requisite information was refused to her.

## Information sought vide RTI application :-

The appellant vide his RTI application had sought information on six (06) points i.e. why not FIR was registered till date against accused, why not action taken on her complaint by police, what action taken by IGP, DSP, Police Department, Chandigarh Admn., etc. What action taken against students who gave false statements etc. How FIR was not filed etc.

### COMMENTS OF CPIO/Hqrs :-

CPIO/Hqrs vide his comments submitted that RTI application of the appellant was received in his office through online RTI portal vide No. PODEP/R/E/23/00128 dated 12.02.2023 to supply the information on six points related to her grievances. Thereafter, relevant record was perused thoroughly and RTI application was returned to the applicant with the remarks that she has already received the available information so many times after inspection of relevant files so many times yet she is filing RTI applications repeatedly on the same issue and raised many objections in her RTI applications for not providing answers to her questions/queries. Moreover, all available information has already been provided to the appellant and an affidavit has also been filed by the CPIO/Hqrs in this matter as per the orders of Hon'ble CIC, New Delhi.

### **DECISION:-**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Hqrs vis-à-vis material available on record which revealed that the

appellant had sought information on six (06) points i.e. why not FIR was registered till date against accused, why not action taken on her complaint by police, what action taken by IGP, DSP, Police Department, Chandigarh Admn., etc. What action taken against students who gave false statements etc. How FIR was not filed etc.

In reply, CPIO/Hqrs informed the appellant after thorough perusal of his record that the available information has already been provided to her so many times after inspection of relevant files yet applicant is filing RTI applications repeatedly on the same issue and raised many objections vide her RTI applications for not providing answers to her questions/queries which are not relevant under RTI act. Moreover, an affidavit has also been filed by the CPIO/Hqrs in this matter as per the orders of Hon'ble CIC, New Delhi.

Moreover, it is also pertinent to mention here that the appellant vide her RTI applications/appeals, has been raising her grievances repeatedly about the process of enquiry by local police and alleging that enquiry has not been conducted according to his assumptions, these contentions of appellant cannot be entertained under RTI act as only available information can be supplied under this act. She has already been intimated that she should raised her grievances at different platform before competent authority.

In view of above, it is clear that available information has already been provided by CPIO/Hqrs many times to the appellant yet, for the satisfaction of the appellant, CPIO/Hqrs is hereby directed to provide available information to her once again in accordance with RTI act, if she again approaches him for the same.

With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of his appeal, she can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
