### **ORDER**

The appellant has preferred his 1<sup>st</sup> appeal dated 17.02.2025 against the disposal of his RTI application dated 09.01.2025 by CPIO/Central with the contentions that requisite information was not provided to him.

## Information sought vide RTI application :-

The appellant vide his RTI application had sought information regarding status of complaint bearing No. ICMS/2024/033745.

### COMMENTS OF CPIO/Central:-

CPIO/Central vide his comments submitted that the RTI application was received in his office to obtain the requisite information. Thereafter, requisite information was obtained from SHO PS-11, Chandigarh, who reported that after the completion of inquiry, the said complaint was sent to senior officers on 20.01.2025. The reply was uploaded at online RTI Portal vide No. 14/RTI-25/CPIO-Central/Chandigarh dated 07.02.2025.

## **DECISION:-**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought information regarding status of complaint bearing No. ICMS/2024/033745.

In reply, CPIO/Central has apprised the appellant through online RTI Portal vide No. 14/RTI-25/CPIO-Central/Chandigarh dated 07.02.2025 that complaint in question is still under enquiry.

Now as far as the appeal is concerned, CPIO/Central has already provided the requisite information sought by the applicant through online RTI Portal vide

No. 14/RTI-25/CPIO-Central/Chandigarh dated 07.02.2025. Hence, no more action is required to be taken on this instant 1<sup>st</sup> appeal.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
