

**THE SUPERINTENDENT OF POLICE HQs.-CUM-APPELLATE AUTHORITY-
ESTABLISHMENT, UNDER RIGHT TO INFORMATION ACT, 2005.**

Order on First Appeal u/s 19 RTI Act.

This is an order on an online First Appeal bearing no. PODEP/A/E/25/00025 dated 12.03.2025, preferred by Sh. Tarminder Singh R/o # 2206, Sector-45/C, Chandigarh, under RTI Act 2005, received in office online through RTI Request & Appeal Management Information System (RTI-MIS), against the disposal of his online RTI Application bearing No. PODEP/R/E/25/00091 dated 11.02.2025 by CPIO/Establishment.

(2) The appellant, vide his application dated 11.02.2025 under RTI Act 2005, had requested CPIO to supply him some information in 04 points related to retirement, pension and other details of SI Alam Chand Belt No. 1247/CHG. Nodal Officer/PHQ has transferred the application to CPIO/Establishment vide No. PODEP/R/E/25/00091 and to CPIO/Accounts vide No. PODEP/R/E/25/00091/1 for its proper disposal. CPIO/Establishment has disposed of the RTI application, vide No. 29/RTI-25/CPIO(Estt.)/UT 12629 dated 07.03.2025.


(3) The appellant, not satisfied with the information supplied by the CPIO against his RTI application bearing No. PODEP/R/E/25/00091, has filed the instant online appeal to provide right information.

(4) Comments of CPIO have been called for. I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by CPIO/Establishment. CPIO in his comments has submitted that the appellant has requested information in four points regarding the personal details of SI Alam Chand (Belt No. 1247/CHG), out of which only point No. 1 i.e. date of retirement of SI Alam Chand Belt No. 1247/CHG and at which designation he retired, pertains to the their office. The requisite information for point No. 1 was denied under Section 8(1)(j) of the RTI Act, as it pertains to a third party, through this office letter No. 29/RTI-25/CPIO/Estt/UT/12629, dated 03.07.2025

(5) **Decision:-**

I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by CPIO/Establishment. The undersigned being First Appellate Authority is satisfied with the reply and comments of CPIO/Establishment. Therefore, no more action is required into the matter. The appeal bearing PODEP/A/E/25/00025 filed against the disposal of RTI application bearing No. PODEP/R/E/25/00091 is hereby disposed off, accordingly.

(6) The appellant, if not satisfied with the disposal of appeal in the manner as above can file second appeal to the Hon'ble Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munrika, New Delhi-110067 within a period of 90 days.
