ORDER *****

The appellant has preferred 1st appeal against the reply/order of CPIO/Central in connection with his RTI application dated 20.01.2022 (received to CPIO/Central on 18.02.2022) mentioning therein that the requisite information has wrongly been denied under section 8(1)(h) of RTI act. The instant appeal has been diarized vide No. 24/UT/RTI/FAA/SSP dated 21.03.2022 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:

Vide his RTI application dated 20.01.2022, the appellant had sought certified copy of FIR registered in connection with the transfers of senior officers of Punjab Police by forging signatures of DGP Punjab.

COMMENTS OF CPIO/Central: -

CPIO/Central submitted that after obtaining the report from SHO PS Sector 03, the requisite information was denied u/s 8(1)(h) of RTI act as the information was sensitive in nature and the case was under investigation.

DECISION:-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record. The matter pertains to case FIR No. 06 dated 11.06.2022 u/s 419, 420, 467, 468, 471, 120 B IPC and 7A/13 of PC Act, PS Sector 03, Chandigarh. At the time of disposal of RTI application, the instant case was under investigation and the information was rightly denied by the CPIO u/s 8(1)(h) of RTI act.

Now, as far as the instant appeal is concerned, after completion of investigation, the case in question has been Put in Court on 26.04.2022 and providing the requisite information at this stage would impede the process of prosecution, hence, the same is denied u/s 8(1)(h) of RTI act.

So far as the issue of dates (i.e. 30.10.2021 & 03.11.2021) of RTI application is concerned, CPIO/Central reported that the same were written inadvertently due to clerical mistake, the actual date of RTI application is 20.01.2022.

With this, the appeal stands disposed off, accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
