**ORDER**

The appellant has preferred 1<sup>st</sup> appeal through online RTI portal vide no. PODEP/A/E/23/00024 dated 03.03.2023 against the disposal of his online RTI application bearing no. PODEP/R/E/23/00122 dated 11.02.2023 by CPIO/East with the contentions that requisite information was not provided to him.

**Information sought vide RTI application :-**

The appellant vide his RTI application dated 22.01.2023 had sought information on three (03) points pertaining to case FIR No. 225/2015, PS Ind. Area, Chandigarh i.e. reason for not giving Amit Gupta CFSL report to Court, have you match the specimen of Amit Gupta with the record, if the report is not present the reason for the same etc.

**COMMENTS OF CPIO/East :-**

CPIO/East vide his comments submitted that RTI application was received through online RTI portal vide no. PODEP/R/E/23/00122 dated 11.02.2023. Accordingly, requisite information was obtained from SHO PS Ind. Area, Chandigarh who reported that after completion of investigation, challan of case FIR No. 225 dated 28.05.2015 u/s 406, 407, 467, 468, 471, 120 B IPC PS Ind. Area, Chandigarh has already been submitted before the learned Court. The appellant was informed accordingly vide letter no. 41-RTI/CPIO/East dated 03.03.2023. So, available information has already been supplied to the appellant.

**DECISION :-**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/East vis-à-vis material available on record which revealed that the appellant had sought information on three (03) points pertaining to case FIR No.




225/2015, PS Ind. Area, Chandigarh i.e. reason for not giving Amit Gupta CFSL report to Court, have you match the specimen of Amit Gupta with the record, if the report is not present the reason for the same etc.

In reply, CPIO/East informed the appellant that after completion of investigation, challan of case FIR No. 225 dated 28.05.2015 u/s 406, 407, 467, 468, 471, 120 B IPC PS Ind. Area, Chandigarh has already been submitted before the learned Court. Moreover, appellant has raised questions about the process of investigation i.e. reason for not giving Amit Gupta CFSL report to the Court, have you match the specimen of Amit Gupta with the record, if the report is not present the reason for the same etc. which cannot be entertained under RTI Act. Only available information can be supplied under RTI act.

In view of above, it clearly evident that available information has already been supplied to the appellant, so, no more action is required to be taken in the matter. However, appellant is hereby advised to raise his grievances before the competent authority and approach the concerned Court for further proceedings.

With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
