ORDER

The appellant has preferred 1st appeal against the reply/order of CPIO/Central in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 32/UT/RTI/FAA/SSP dated 27.04.2021 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:-

Appellant had sought information on 02 points pertaining to complaint made by Sh. Pawan Kumar, ADM-cum-Works Manager, CTU-III and copy of statement etc.

COMMENTS OF CPIO/CENTRAL : -

CPIO/Central submitted that application of the appellant was received for supplying requisite information. Thereafter, report from SHO/PS-

was obtained and thereafter, requisite information was supplied to the appellant vide letter No. 96/RTI-121/CPIO-Central/UT dated 03.04.2021. As of now, no information was left for supplying to the appellant.

DECISION:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that appellant had sought information 02 points pertaining to complaint made by Sh. Pawan Kumar, ADM-cum-Works Manager, CTU-III and copy of statement etc.

Insofar as appeal is concerned, it is clear that requisite information has already been supplied but appellant also wants copy of DDR No 14 lodged in Police Post Sector 24, Chandigarh, mentioned in DDR No. 17 which was supplied to him. In the spirit of RTI Act, the copy of above said DDR can be supplied to the appellant. Hence, this appeal is hereby disposed of with the direction to CPIO/Central to supply the aforesaid information to appellant as per RTI Act.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
