

**THE SUPERINTENDENT OF POLICE HQs.-CUM-APPELLATE AUTHORITY-  
HEADQUARTERS (DEs), UNDER RIGHT TO INFORMATION ACT, 2005.**

**Order on First Appeal u/s 19 RTI Act.**

This is an order on First Appeal dated 08.03.2025, preferred by Sh. Pardeep Sharma R/o # 3032, Sector-35/D, Chandigarh, under RTI Act 2005, submitted through email id [pardeep.paddy.sharma@gmail.com](mailto:pardeep.paddy.sharma@gmail.com) to SSP/UT, against the disposal of his RTI Application dated 17.02.2025 by CPIO/Sub Division South West, vide letter No. 34/RTI/CPIO/PHQ dated 05.03.2025. SSP/UT-cum-FAA transferred the part appeal to this office for its proper disposal, as the point No. 02 of RTI application was dealt by CPIO/HQs. (DEs Centralized) and the undersigned is the First Appellate Authority w.r.t. CPIO/HQs. (DEs Centralized).

(2) The appellant, vide his email dated 14.02.2025 has requested to provide him some information in 05 points. Incharge Public Window (PHQ)-cum-CAPIO, PHQ, Sector-09, Chandigarh further marked point No. 01, 03, 04 and 05 to CPIO/Sub Division South West and point No. 02 to DSP/Admin-cum-CPIO for its proper disposal. Later on, CPIO/Sub Division South West transferred the point No. 02 of RTI application to CPIO/HQs. (DEs Centralized) for its proper disposal on 05.03.2025. CPIO/HQs. (DEs Centralized) disposed off the same vide No. 94/CPIO/Hqrs./RTI-22/D-575 dated 20.03.2025.


(3) The appellant, not satisfied with the information supplied by the CPIO against his RTI application and has filed the instant online appeal to provide right information.

(4) Comments of CPIO have been called for. I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by CPIO/HQs.(Centralized). The information sought by the appellant, supplied by the CPIO and the order/decision of the undersigned being first appellate authority is given below:-

Information sought	Information provided by CPIO	Decision
<b>Point No. 02</b> Demotion orders of Harinder Singh Sekhon Inspector.	<b>Point No. 02</b> The requisite information is personal information of individual and is not in larger public interest. So, the sought information/documents, denied us 8(1)(j) of RTI Act, 2005 being third party information.	<b>Point No. 02</b> The undersigned being First Appellate Authority is satisfied with the reply of CPIO/HQs.(Centralized). Hence, no further action is required into the matter.

(5) The appeal is hereby disposed off, accordingly.

(6) The appellant, if not satisfied with the disposal of appeal in the manner as above can file second appeal to the Hon'ble Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munrika, New Delhi-110067 within a period of 90 days.
