<u>ORDER</u>

The appellant has preferred 1st appeal through online portal vide no. PODEP/A/E/23/00021 dated 01.03.2023 against the disposal of his online RTI application bearing no. PODEP/R/E/23/00058 dated 18.01.2023 by CPIO/Central with the contentions that reply of CPIO is unsatisfactory.

Information sought vide RTI application :-

The appellant vide his RTI application dated 18.01.2023 had sought information pertaining to case FIR No. 105 dated 10.04.2019 PS Sector 17, Chandigarh i.e. full investigation report and documents.

COMMENTS OF CPIO/Central:

CPIO/Central vide his comments submitted that RTI application of the appellant was received in his office through online RTI portal vide No. PODEP/R/E/23/00058 dated 18.01.2023. Thereafter, requisite information was obtained from PS Sector 17 who reported that case FIR No. 105 dated 10.04.2019 u/s 420, 467, 471 IPC PS Sector 17, Chandigarh was registered on the complaint of the appellant and after completion of investigation, the said case was sent for cancellation on 10.02.2021 after getting approval from the senior officers and the same is pending before the concerned Court for its final acceptance. Hence the information was denied to the appellant vide letter no. 21 & 22/RTI-23/CPIO-Central/UT dated 11.02.2023.

DECISION:-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that the appellant had sought information pertaining to case FIR No. 105 dated 10.04.2019 u/s 420, 467, 471 IPC PS Sector 17, Chandigarh i.e. full investigation report and documents.

In reply, CPIO/Central denied the requisite information to the appellant u/s 8(1)(h) of RTI act as after completion of investigation case FIR No. 105 dated 10.04.2019 u/s 420, 467, 471 IPC PS Sector 17, Chandigarh was sent for cancellation on 10.02.2021 after getting approval from the senior officers and the same is pending before the concerned Court for its final acceptance.

So far as the instant appeal is concerned, the FIR in question is still pending for acceptance before the learned Court, hence the requisite information cannot be supplied and denied u/s 8(1)(h) of RTI act. However, appellant is advised to approach the concerned Court for requisite information.

With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
