

**THE SUPERINTENDENT OF POLICE HQs.-CUM-APPELLATE AUTHORITY-
ACCOUNTS BRANCH, UNDER RIGHT TO INFORMATION ACT, 2005.**

Order on First Appeal u/s 19 RTI Act.

This is an order on the online First Appeal bearing No. PODEP/A/E/25/00023 dated 03.03.2025, preferred by Sh. Surinder Kumar R/o H.No. 1147/A, Small Flats, Dhanas,, Chandigarh under RTI Act 2005, received in this office through online RTI MIS portal, against the disposal of his RTI Application bearing No. PODEP/R/E/25/00095 dated 12.02.2025 by CPIO/Accounts.

(2) The appellant, vide his application dated 12.02.2025 under RTI Act 2005, had requested Nodal Officer, Police Headquarters, Sector-9, Chandigarh to supply him some information w.r.t. allotment of House No. 79, Sector-26, Chandigarh. CPIO/Accounts disposed off the RTI Application on 28.02.2025, vide letter No. 11/RTI/CPIO(Accts)/2025/UT/6734.


(3) The appellant is not satisfied with the information supplied to him, has filled instant appeal aggrieving that the CPIO/Accounts has refused access to information request. The comments of DSP/HQs-cum-CPIO/Accounts have been called for.

(4) Comments of CPIOs have been called for. I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by CPIO. The information sought by the appellant, supplied by the CPIO and the order/decision of the undersigned being first appellate authority is given below:-

Information sought in RTI application	Information provided	Decision
House no. 79, ground floor, Sector-26, Chandigarh, situated inside the police lines, in whose name has it been allotted now and since when has it been allotted to them?	The requisite information is denied under section 8 (1) J of RTI Act, 2005 being third party information.	The undersigned is satisfied with the reply submitted by the CPIO.

(5) The appeal is hereby disposed off, accordingly.

(6) The appellant, if not satisfied with the disposal of appeal in the manner as above can file second appeal to the Hon'ble Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munrika, New Delhi-110067 within a period of 90 days.
