ORDER

The appellant has preferred her 1st appeal against the reply of CPIO/South in connection with her RTI application with the contentions that requisite information was not supplied to her. The instant appeal was diarized vide No. 38/UT/RTI/FAA/SSP dated 19.04.2022 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:-

The appellant had sought information on 06 points i.e. confirm Chandigarh Police has received notice/application u/s 156(3) CrPC, certified copy of statement of Mohan and Jagjit Singh, reason for not taking the statement of Jagjit Singh, has Chandigarh Police done any investigation with Jagjit Singh, what is the reason behind submitting wrong/no reply to Women Commission etc.

COMMENTS OF CPIO/South : -

CPIO/South submitted that RTI application of the appellant was received in his office through online RTI portal vide no. PODEP/R/E/22/00165 dated 06.03.2022 and the requisite information was obtained from SHO PS Sector 31, Chandigarh who submitted that point-wise reply was sent to the appellant vide letter no. 90/CPIO/South dated 05.04.2022 mentioning therein that no notice u/s 156(3) CrPC has been received in PS Sector 31, Chandigarh and regarding other points, appellant has not mention any case/complaint regarding which statement of Jagjit Singh was to be taken by local Police etc.

DECISION:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that CPIO has supplied the available information in pointwise form to the appellant.

Now, as far as the appeal is concerned, CPIO has informed that no notice/application u/s 156(3) CrPC has been received through Courts Sector 43, Chandigarh in PS Sector 31 and regarding other points, available information has already been supplied to the appellant.

As the available information has already been supplied to the appellant by the CPIO, so no more action is required to be taken on the instant appeal and the same is filed accordingly.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
