ORDER

The appellant has preferred her 1st appeal dated 29.04.2024 against the disposal of her RTI application dated 18.03.2024 by CPIO/North-East with the contentions that requisite information was not provided to her.

Information sought vide RTI application :-

The appellant vide her RTI application dated 04.04.2024 had sought information on 10 points regarding FIR No. 183 dated 17.10.2019 registered at PS- Mauli Jagran, Chandigarh i.e. name of IO, progress report of FIR, details of arrested person, copy of report u/s 173 CrPC, details of recovered items, present status of FIR, copy of zimini report of Ld Illaqa Magistrate, copy of zimini report of IO and copy of all notices issued.

COMMENTS OF CPIO/North-East:-

CPIO/North-East vide his comments submitted that RTI application of the appellant was received in his office to supply the information. Thereafter, requisite information was obtained from SHO- Mauli Jagarn and accordingly, appellant was provided the name of IO and provided the status of FIR to the appellant. Applicant was apprised about the same vide letter No. 42/RTI/CPIO/North-East dated 20.03.2024.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/North-East vis-à-vis material available on record which revealed that the appellant vide her RTI application had sought information on 10 points regarding FIR No. 183 dated 17.10.2019 registered at PS- Mauli Jagran, Chandigarh i.e. name of IO, progress report of FIR, details of arrested person, copy of report u/s 173 CrPC, details of recovered items, present status of FIR, copy of zimini report of Ld Illaqa Magistrate, copy of zimini report of IO and copy of all notices issued.

In reply, CPIO/North-East provided the name of IO and provided the status of FIR to the appellant.

Now as far as appeal is concerned, CPIO/North-East has provided the sought information to the appellant, however, appellant is not satisfied with reply provided by the CPIO. Therefore, to achieve the objectives and transparency of RTI Act, CPIO/North-East is hereby directed to provide pointwise reply to the appellant strictly as per the provisions of RTI Act.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
