ORDER

The appellant has preferred 1st appeal against the reply/order of CPIO/Central in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 137/UT/RTI/FAA/SSP dated 07.12.2021 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:-

Appellant had sought information on four points regarding Complaints filed by appellant i.e. statements of accused, Copy of letter sent to Punjab education department and status report of complaints etc.

COMMENTS OF CPIO/Central: -

CPIO/Central submitted that appellant has filed RTI application for obtaining information, who reported that complaints in question were under enquiry, therefore denied u/s 8 (1) (h) of RTI Act. But, now the same has been sent to senior officers after investigation.

DECISION:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that appellant had sought information on four points regarding Complaint No. PW. 2020- 15616, 15723 & 17612 i.e. statements of accused, Copy of letter sent to Punjab education department and status report of complaints etc.

Insofar appeal is concerned; it is clear that complaints in question are still under consideration for finalizing the same, therefore; requisite information cannot be supplied at this stage. However, keeping in view that appellant complainant party in the complaint, therefore; CPIO/Central is hereby directed to

obtain the copy of the complaint filed by complainant from quarter concerned and supply the same to the applicant and also apprise him about the current status as per RTI Act. Appeal stands disposed of, accordingly.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
