ORDER

The appellant has preferred online 1st appeal bearing no. PODEP/A/E/24/00031 dated 09.05.2024 against the disposal of his RTI application dated 29.04.2024 by CPIO/Hqrs with the contentions that requisite information was not provided to him.

Information sought vide RTI application :-

The appellant vide his RTI application dated 29.04.2024 had sought present status of complaint bearing no. PW-201810963.

COMMENTS OF CPIO/Hqrs:-

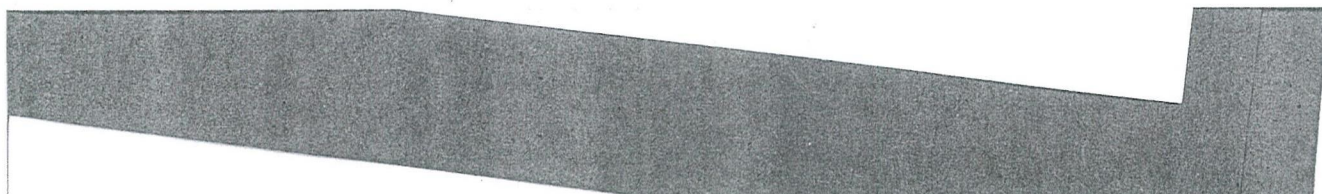
CPIO/Hqrs vide his comments submitted that RTI application of the appellant was received in his office to supply the requisite information. Thereafter, requisite information was obtained from I/C HAC who reported that complaint in question has been filed with HAC Branch after finalization of the enquiry. Applicant was apprised about the same vide letter No. 98/CPIO/Hqrs/Online RTI-24 D-78 dated 08.05.2024.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Hqrs vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought present status of complaint bearing no. PW-201810963.

In reply, CPIO/Hqrs has apprised the current status of the complaint to the appellant.

So far as present status of this case is concerned, appellant has now raised contentions that copy the action taken report of the complaint. Now, considering the contentions of the appellant and to achieve the objectives of the RTI Act, CPIO/Hqrs



is hereby directed to provide the details of the action taken report to the appellant, strictly as per the provisions of RTI Act.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
