ORDER

The appellant has preferred 1st appeal dated 02.03.2023 against the disposal of his RTI application dated 12.02.2023 by CPIO/North-East with the contentions that requisite information was denied to him.

Information sought vide RTI application :-

The appellant vide his RTI application dated 22.01.2023 had sought information on 04 points :-

- 1) (a) Kindly provide me fair and certified photocopy as per DOPT Guidelines of complete complaint case i.e. bears as no. 12210-R dated 17 June 2022 made by Dr. Prachi Maan.
- (b) Complaint case i.e. bears as ICMS/2022/004772 dated 28 July 2022 made by Ashok Kumar.
- (c) Complaint case i.e. bears as ICMS/2022/009163 made by Manesh Kumari.
- (d) FIR No. 90 dated 09.07.2022 PS Mouli Jagran UT Chd kindly provides the writing report of CFSL Mr. Sumit and Daljit Singh.

COMMENTS OF CPIO/North-East :-

CPIO/ vide his comments submitted that RTI application of the appellant was received in his office through online RTI portal vide No. PODEP/R/E/23/00125 dated 12.02.2023. Thereafter, requisite information was obtained from PS Mauli Jagran and the appellant was informed vide letter no. 21/RTI/CPIO/North-East dated 14.02.2023 that information sought vide point no. 1(a) could not be supplied as the complaint bearing no. 12210-R dated 17 June 2022 made by Dr. Prachi Maan was not found received in PS Mauli Jagran, Chandigarh. However, a complaint made by Dr. Prachi Maan bearing No. ICMS/2023/00160 dated 03.01.2023 was received in PS Mauli Jagran and the same is under enquiry. Apart from this, information sought vide point nos. 1 (b), (c) & (d) also could not be supplied as complaints bearing Nos. ICMS/2022/004772 & ICMS/2022/009163 were under enquiry and Case FIR No. 90 dated 09.07.2022 PS Mouli Jagran UT Chandigarh was under investigation at that time. So requisite information was denied u/s 8(1)(h) of RTI act. As far as the present status of these complaints are concerned, the complaints bearing nos. ICMS/2023/00160 & ICMS/2022/004772 are still under

enquiry and complaint bearing no. ICMS/2022/009163 is transferred to PS Sector 49 for further enquiry. Similarly, investigation in Case FIR No. 90 dated 09.07.2022 PS Mouli Jagran is still going on.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/North-East vis-à-vis material available on record which revealed that the appellant had sought information on 04 points regarding complaint bearing no. 12210-R dated 17 June 2022 made by Dr. Prachi Maan and complaints bearing nos. ICMS/2022/004772 & ICMS/2022/009163 and Case FIR No. 90 dated 09.07.2022 PS Mouli Jagran, Chandigarh.

In reply, CPIO/North-East denied the requisite information to the appellant u/s 8(1)(h) of RTI act as complaints bearing Nos. ICMS/2022/004772 & ICMS/2022/009163 were under enquiry and Case FIR No. 90 dated 09.07.2022 PS Mouli Jagran UT Chandigarh was under investigation at that time. And complaint bearing no. 12210-R dated 17 June 2022 made by Dr. Prachi Maan was not found received in PS Mauli Jagran, Chandigarh.


It is pertinent to mention here that the record of Reader Branch of the undersigned was also examined carefully for tracing the complaint bearing no. 12210-R dated 17 June 2022 made by Dr. Prachi Maan which revealed that the said complaint/reference was sent to SDPO-cum-CPIO/North-East on 29.06.2022 for further necessary action.

So far as the present status of the complaints in question is concerned, the same are still under enquiry. Similarly, investigation in Case FIR No. 90 dated 09.07.2022 PS Mouli Jagran, Chandigarh is still going on. Hence, information cannot be supplied at this stage also and denied u/s 8(1)(h) of RTI act.

However, to uphold the spirit of RTI act and for the satisfaction of the appellant, CPIO/North-East is hereby directed to supply the available information to the appellant as per RTI act as and when the enquiries into the aforementioned complaints (ICMS/2022/004772 & ICMS/2022/009163) is finalized and the appellant will also be apprised about the present status of the complaint/reference bearing no. 12210-R dated 17 June 2022 made by Dr. Prachi Maan.

With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
