ORDER

The appellant has preferred 1st appeal against the reply/order of CPIO/Central in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 37/UT/RTI/FAA/SSP dated 14.05.2021 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:-

The appellant had sought information pertaining to his complaint lodged on police control room (100 number) i.e. copy of statement, DDR No. 49 & 60 dated 11.02.2021 lodged at PS-03.

COMMENTS OF CPIO/CENTRAL: -

Comments of CPIO/Central submitted that RTI application of the appellant had been received from CPIO/Communication vide No. 59-60/CPIO/Comm. dated 12.03.2021 for supplying the information on two points. Thereafter, report from SHO-PS-03 was obtained and points wise reply/information was sent to the applicant by post at his given address vide No. 91/CPIO-Central dated 05.04.2021. On 30.04.2021, the complainant rang up in the CPIO/Central office and told about non receipt of reply of his RTI

application. Consequently, information was provided to appellant through special messenger on 03.05.2021.

DECISION:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that appellant had sought information pertaining to his complaint lodged on police control room (100 number) i.e. copy of statement, DDR No. 49 & 60 dated 11.02.2021 lodged at PS-03.

Whereas, CPIO/Central has contended that information on point No. 2 & 3 has already been provided but appellant is pleading in his appeal that he had not received any information. Hence, CPIO/Central is hereby directed to supply once again the requisite information to the appellant with proper acknowledgement of receipt, free of cost, as per RTI Act.

As far as appeal is concerned with point No. 1, the same is relates with CPIO/Communication, therefore, the same is hereby transferred to FAA-cum-SP/Hqrs vide this office No. D-162/UT/RTI/SSP/FAA. The instant appeal stands disposed as far this office is concerned.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
