ORDER

The appellant has preferred his 1st appeal dated 03.05.2024 against the disposal of his RTI applications dated 11.03.2024 by CPIO/Central with the contentions that the sought information was not provided to him.

Information sought vide RTI application :-

The appellant vide his RTI applications dated 11.03.2024 had sought the investigation report, minute sheet along with action taken on Administration letter No. No. 841-III(2)-2018/6068 dated 21.03.2018.

Comments of CPIO/Central :-

CPIO/Central vide his comments submitted that RTI application of the appellant was received in his to supply the information pertaining to letter No. 841-III(2)-2018/6068 dated 21.03.2018. Thereafter, requisite information was obtained from SHO-17, who reported that case FIR No. 347 dated 06.09.2016 was registered at PS-17 and the same was submitted in Hon'ble Court on 29.07.2027. During Investigation many representations were received from Brig. Anil Kumar. However, letter sought by the appellant is not found in the record of PS-17, Chandigarh. Appellant was apprised about the same vide letter No. 69 & 84/RTI-24/CPIO-Central dated 18.04.2024.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Central. vis-à-vis material available on record which revealed that the appellant had sought investigation report, minute sheet along with action taken on Administration letter No. No. 841-III(2)-2018/6068 dated 21.03.2018.

In reply, CPIO/Central had apprised the appellant that a case FIR No. 347 dated 06.09.2016 was registered at PS-17 and the same was submitted in Hon'ble Court on 29.07.2027. During Investigation many representations were received from Brig. Anil Kumar. However, letter sought by the appellant is not found in the record of PS-17, Chandigarh.

So far as the appeal is concerned, necessary action has already been taken on all the correspondence made by the appellant in case FIR No. 347 dated 06.09.2016 registered

at PS-17, Chandigarh, however, the letter sought by the appellant was not traceable in the record.

In view of above, it is clearly evident that letter in question, was misplaced or missing from the office of CPIO/Central and reply of CPIO/Central is not satisfactory as the appellant has every right to seek information under RTI act. Henceforth, CPIO/Central is hereby directed to make sincere efforts to trace the relevant letter so that requisite information can be supplied to the appellant under RTI act. And if the same are traced, supply the requisite information to the appellant free of cost with immediate effect and if the same are not traced submit the report detailing the steps taken to trace the relevant files. With these observations, instant appeals stands disposed off.

With these observations, the instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
