ORDER

The appellant has preferred his online 1st appeal bearing No. PODEP/A/E/23/00026 dated 22.03.2023 against the disposal of his online RTI application bearing No. PODEP/R/E/23/00166 dated 01.03.2023 by CPIO/Hqrs with the contentions that information about complaint filed by some foreign agency against the appellant was not provided to him.

Information sought vide RTI application :-

The appellant vide his RTI application bearing No. PODEP/R/E/23/00166 dated 01.03.2023 had sought information pertaining to a complaint filed by any foreign agency against the appellant i.e. allegations of the complaint, complainant, method of complaint and statement of the appellant etc.

COMMENTS OF CPIO/Hqrs :-

CPIO/Hqrs vide his comments submitted that RTI application of the appellant was received in his office thorough online RTI Portal vide No. PODEP/R/E/23/00166 dated 01.03.2023. Thereafter, requisite information was obtained from I/C PWS/ICMS who submitted that as per record of Public Window Computer Record System, no complaint has been found against the appellant and the appellant has been appraised accordingly vide letter No. 73/CPIO/Hqrs/Online/RTI-23, D-51 dated 22.03.2023.

DECISION:-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Hqrs., vis-à-vis material available on record which revealed that the appellant had sought information pertaining to a complaint filed by any foreign agency against the appellant i.e. allegations of the complaint, complainant, method of complaint and statement of the appellant etc.

In reply, CPIO/Hqrs. had appraised the appellant that as per record of Public Window Computer Record System, no complaint has been found against the appellant.

So far as the appeal is concerned, the appellant has already informed that no complaint has been found against him at Public Window or Integrated Complaint Management System (ICMS), hence, CPIO/Hqrs. has appropriately disposed off the RTI application. No more action is required to taken in the matter. With these observations, instant appeal stands disposed off as far as the office of the undersigned is concerned.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
