<u>ORDER</u>

The appellant has preferred his online 1st appeal bearing No. PODEP/A/E/23/00027 dated 24.03.2023 against the disposal of his online RTI applications bearing No. PODEP/R/E/23/00070 & 65 dated 23 & 25.01.2023 by CPIO/Hqrs & South with the contentions that information pertaining to point nos. 1, 2 & 6 was not provided to him.

Information sought vide RTI application:-

The appellant vide his RTI applications bearing No. PODEP/R/E/23/00065 & 70 dated 2. & 25.01.2023 had sought information on 07 points pertaining to an incident of quarrel took place on the intervening night of 02/03.09.2022 and complaint bearing No. ICMS/2022/008111 dated 06.09.2022 i.e. total number of information (ruka) received in PS 31 from GMCH – 32 against MLC cases from 01.01.2022 to 02.02.2022, any information received in PS 31 from GMCH-32 in connection with MLC Card No. 220901362 on the intervening night of 02/03.09.2022, total number of summons issued by I/O for investigation, total number of statements recorded by I/O and their copies, request letter submitted by I/o in GMCH-32 for obtaining MLR, Copy of MLR, copies of four persons shown in the video clip etc.

COMMENTS OF CPIO/Hqrs :-

CPIO/Hqrs vide his comments submitted that RTI application of the appellant was received in his office thorough online RTI Portal to supply the requisite information pertaining to complaint bearing No. ICMS/2022/008111 dated 06.09.2022. Thereafter, requisite information was obtained from the concerned branch and the same (consisting of 30 pages) has been supplied to the appellant after inspection of the relevant complaint file vide letter No. 22/CPIO/Hqrs/Online/RTI-23 dated 20.02.2023.

Comments of CPIO/South:

CPIO/South vide his comments submitted that RTI application of the appellant was received in his office for supplying the information on 07 points pertaining to an incident of quarrel took place on the intervening night of 02/03.09.2022 and complaint

bearing No. ICMS/2022/008111 dated 06.09.2022. Thereafter, RTI application was also transferred to CPIO/Hqrs as the said complaint has already been consigned to record in HAC branch after completion of enquiry and the appellant was informed accordingly. As far as the appeal is concerned, the requisite information pertaining to point nos. 1, 2 & 6 of RTI application has been obtained from PS Sector 31 who submitted that total 54 information (ruka) have been received in PS 31 from GMCH – 32 from 01.01.2022 to 02.02.2022 and DDR No. 10 dated 03.09.2022 was lodged in PS 31 in connection with MLC case No. 220901362 & I/O is ASI Balbir Singh No. 2649/CP and copy of MLR is also obtained from PS 31. The same is ready to be supplied under RTI act.

DECISION:-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Hqrs. and South vis-à-vis material available on record which revealed that the appellant had sought information on 07 points pertaining to an incident of quarrel took place on the intervening night of 02/03.09.2022 and complaint bearing No. ICMS/2022/008111 dated 06.09.2022.

In reply, CPIO/Hqrs. had supplied the available information (consisting of 30 pages) pertaining to complaint No. ICMS/2022/008111 dated 06.09.2022 after inspection of the relevant file.

CPIO/South also obtained the requisite information from quarter concerned and after perusing the same, transferred the RTI application to CPIO/Hqrs for further necessary action.

So far as the appeal is concerned, CPIO/South has obtained the requisite information pertaining to point nos. 1, 2 & 6 from the quarter concerned (SHO PS 31) and the same is ready to be supplied under RTI act.

Accordingly, CPIO/South is hereby directed to supply the available information pertaining to point nos. 1, 2 & 6 to the appellant, as per RTI act. With these observations, the instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
