ORDER

The appellant has preferred 1st appeal dated 17.03.2025 against the disposal of his RTI application dated 03.01.2025 by CPIO/Admn with the contentions that requisite information was not provided to him.

Information sought vide RTI application :-

The appellant vide his RTI application has sought attested copy of action taken report on order received from PSHRC with case no. 3553/30/2023 and police report as submitted to the commission.

COMMENTS OF CPIO/Admn :-

CPIO/Admn vide his comments submitted that RTI application was received in his office to obtain the requisite information. Thereafter, requisite information was obtained from I/C HAC and the same was supplied to the applicant in the shape of 07 pages through e-mail vide letter No. 114/RTI-24/DSP/Admn Dated 06.03.2025.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Admn vis-à-vis material available on record which revealed that the appellant vide his RTI application has sought attested copy of action taken report on order received from PSHRC with case no. 3553/30/2023 and police report as submitted to the commission.

In reply, CPIO/Admn has already supplied the available information to the appellant.

Now as far as the appeal is concerned, CPIO/Admn has already provided the sought information to the appellant. Hence, no more action is required to be taken on this instant 1st appeal.

However, CPIO/Admn is hereby advised to dispose of the RTI application within the stipulated time period.

With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
