ORDER

The appellant has preferred her 1st appeal dated 04.05.2022 in connection with disposal of her RTI application dated 05.04.2022.

INFORMATION SOUGHT IN RTI APPLICATION :-

The appellant has sought information pertaining to complaint bearing PWS no. 2014-08667.

COMMENTS OF CPIO/Hgrs: -

Comments of CPIO/Hqrs have been obtained who submitted that RTI application of the appellant was received in his office vide no. 290/RTI/CAPIO(PHQ)/UT/PWS dated 05.04.2022. Thereafter, requisite information was obtained from I/C HAC who reported that complaint in question i.e. PWS No. 2014-08667 has already been destroyed in the year 2018 vide order no. 5117-20/UT/HAC dated 18.07.2018 and appellant was apprised accordingly vide letter No. 190/CPIO/Hqrs/RTI-2022/D-398 dated 18/04/2022.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Hqs. vis-à-vis material available on record which revealed that the requisite information pertains to complaint bearing PWS no. 2014-

08667 and as per norms the same has already been destroyed in the year 2018 vide order no. 5117-20/UT/HAC dated 18.07.2018. Appellant was also apprised accordingly vide letter No. 190/CPIO/Hqrs/RTI-2022/D-398 dated 18/04/2022.

As the available information has already been provided and RTI application of the appellant was rightly disposed off by the CPIO/Hqs, so at present, no action is warranted on the instant appeal and the same is dismissed.

However, in case, the appellant is not satisfied with the disposal of her appeal, she can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
