ORDER \* \* \* \* \* \* \*

The appellant has preferred 1st appeal (bearing No. PODEP/A/E/21/ 00043 dated 19.05.2021) against the reply of CPIO/Central in connection with his RTI application (bearing No. PODEP/R/E/21/00245 dated 30.04.2021) with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 46/UT/RTI/FAA/SSP dated 20.05.2021 for further proceeding under RTI Act.

# INFORMATION SOUGHT IN RTI APPLICATION:-

The appellant had sought copy of all documents with regard to complaint bearing No. 2020-12800 and email compliant dated 01.02.2021.

## COMMENTS OF CPIO/CENTRAL: -

CPIO/Central submitted that appellant has sought information through online RTI application. Report from SHO/PS-11 was obtained who submitted that appellant wants information with regard to point complaint bearing No. 2020-12800 which was under enquiry at that time. So the same was denied u/s 8(1) (h) of RTI Act.

#### DECISION:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that appellant had sought copy of documents with regard to complaint bearing No. 2020-12800 and email compliant dated 01.02.2021.

So far as the appeal is concerned, it is clear that complaint in question i.e. 2020-12800 is still under consideration for finalizing the same. Therefore, requisite information rightly denied by applying section 8(1)(h) of RTI Act. However, considering that appellant is complainant in the aforementioned complaints, therefore, CPIO/Central is hereby directed to supply the copy of statement of the appellant/complainant as per RTI Act. Accordingly, instant appeal stands disposed of.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
