**ORDER**

The appellant has preferred 1<sup>st</sup> appeal through online RTI portal vide no. PODEP/A/E/22/00055 dated 23.05.2022 against the reply/order of CPIO/South in connection with his RTI application dated 20.04.2022 with the argument that he has been provided incomplete, misleading or false information.

**INFORMATION SOUGHT IN RTI APPLICATION:-**

The appellant had sought information regarding action taken by police on his complaint which was lodged in PS 34 vide DDR No.37 dated 26.09.2021 regarding missing/lost of his Apple I-phone X.

**COMMENTS OF CPIO/CENTRAL: -**

Comments of CPIO/South have been obtained who submitted that RTI application of the appellant was received in his office through online RTI portal vide no. PODEP/R/E/22/00274 dated 20.04.2022. Thereafter, report from SHO PS-34 was obtained who intimated that requisite information pertained to missing/lost of a Apple I-phone X mobile phone which was reported vide DDR No. 37 dated 26.09.2021. The IMEI NO. of missing mobile phone has already been put on PAN India surveillance but




no positive report received so far. Whenever any positive report will receive, applicant will be informed accordingly. This information was supplied to the appellant through e mail vide letter no. RTI-137/CPIO-South/UT dated 16.05.2022.

**DECISION:-**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that available information had already been supplied to the appellant by CPIO/South. IMEI No. of missing / lost mobile phone reported vide DDR No.37 dated 26.09.2021 has been put on IMEI surveillance but no positive report received so far and as and when any positive report will receive, action will be taken accordingly as per law.

So far as information sought in question form and in the form of clarification/ justification is concerned, the same is not covered under the purview of RTI act. Hence, no more action is required to be taken on the instant appeal. However, for the satisfaction of the appellant as well as achieving the objective of the RTI Act, SDPO/South is hereby directed to make concrete efforts to trace the missing/lost mobile phone and appellant be informed accordingly. With this, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of this appeal, she can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
