# ORDER

The appellant has preferred 1 st appeal (bearing PODEP/A/E/21/ 00045 dated 22.05.2021) against the reply of CPIO/East in connection with his RTI application (bearing No. PODEP/R/E/21/00241 dated 28.04.2021) with the contentions that requisite information was not him. supplied to The instant appeal was diarized vide No. 47/UT/RTI/FAA/SSP dated 22.05.2021 for further proceeding under RTI Act.

### INFORMATION SOUGHT IN RTI APPLICATION:-

The appellant had sought copies of compete file of his complaint bearing No. 2021-00629.

## **COMMENTS OF CPIO/EAST: -**

CPIO/East submitted that appellant has sought information vide his online RTI application pertaining to complaint No. 2021-00629. At that time, complaint bearing No. 2021-00629 was under consideration. So the same was denied u/s 8(1) (h) of RTI Act. As far as

appeal is concerned, at present, the said complaint has been sent to I/C CRU for further action.

#### **DECISION:-**

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/East vis-à-vis material available on record which revealed that appellant had sought copies of compete file of his complaint bearing No. 2021-00629.

So far as the appeal is concerned, it is clear that complaint in question i.e. 2021-00629 has been consigned with HAC Branch after finalization. Therefore, requisite information can be supplied to the appellant at this stage. Hence, the instant appeal is hereby disposed of with the direction to CPIO/East to supply the requisite information forthwith to the appellant after obtaining from the concerned branch.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
