**ORDER**

The appellant has preferred 1<sup>st</sup> appeal through online RTI portal vide no. PODEP/A/E/22/00060 dated 29.05.2022 against the reply/order of CPIO/South-west in connection with her RTI application submitted through online RTI portal vide no. PODEP/R/E/22/00305 dated 05.05.2022 with the contention that she has been provided incomplete, misleading or false information.

**INFORMATION SOUGHT IN RTI APPLICATION :-**

The appellant vide her RTI application dtd. 05.05.2022 had sought information on 06 points pertaining to a passport verification of File No. CH4076294964022 relates to the appellant herself.

**COMMENTS OF CPIO/South-west: -**

Comments of CPIO/South-west have been obtained who submitted that RTI application of the appellant on 6 points was received in his office on 05.05.2022. Thereafter, requisite information (point wise) was obtained from SHO PS Maloya and the same was further supplied to the applicant vide letter No. 53/RTI/CPIO/South-west, on Dated 25.05.2022. The information sought in point No.6 was denied u/s 8(1)(j) of RTI Act. CPIO/South-west further submitted that after conducting verification, all the documents pertaining to the Passport Verification of the applicant Arvinder Kaur Saini received vide file No. CH4076294964022 has already been sent to Passport Branch PHQ, Sector -9 Chandigarh and nothing is available in PS Maloya now.

**Comments of CPIO/CID :**

To attain the conclusion and for proper disposal of RTI appeal, comments of CPIO/CID have also been sought and as per his comments RTI application of the appellant was received in his office through RTI online portal



vide No. PODEP/R/E/22/00305/1 on dated 05.05.2022. After obtaining the requisite/relevant information from I/C Passport branch the same containing 3 pages was further supplied to the appellant through online as well as physically to Sh. Kulwant Singh( Father in law of appellant) R/O #104, Vill. Dadu Majra, Chandigarh on 25.05.2022 as per undertaking given by the appellant. Information on point No. 6 was not supplied by CPIO/CID being not relates to his unit.


**DECISION :-**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/South-west and CID vis-à-vis material available on record which revealed that the information sought vide RTI application dated 05.05.2022 pertains to a passport verification bearing file No. CH4076294964022 relates to the appellant herself. Available information (Point wise) have already been supplied by both the CPIOs except information sought at point No.6 of RTI application i.e. *"deployment of police personnel at Dadu Majra beat"* which was wrongly denied by CPIO/South-west attracting u/s 8(1)(j) of RTI act. Henceforth, CPIO/South west is directed to supply the requisite information on this point for a particular day/period as per duty roaster of PS Maloya.

So far as providing copy of the report of witness is concerned (as requested by appellant in her 1st appeal), that does not exists in passport verification file and cannot be supplied. Moreover, in this regard a DDR No. 85 dated 18.04.2022 has been lodged in PS Maloya and copy of same has already been supplied to the appellant.

With this, instant appeal stands disposed of accordingly.

However, in case, the appellant is not satisfied with the disposal of her appeal, she can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
