ORDER

The appellant has preferred 1st appeal against the reply of CPIO/South in connection with her RTI application with the contentions that requisite information was not supplied to her. The instant appeal was diarized vide No. 49/UT/RTI/FAA/SSP dated 28.05.2021 for further proceeding under RTI Act.

### INFORMATION SOUGHT IN RTI APPLICATION:-

The appellant had sought information on 04 points pertaining to DDR No. 17, dated 24.01.2021 of PS-31 i.e. videography of, photographs and record relevant to that DDR and CFSL viscera report of deceased Ms. Pooja.

## COMMENTS OF CPIO/SOUTH: -

CPIO/South submitted that RTI application of the appellant has been received in her office on 07.04.2021 by post for obtaining requisite information pertaining to DDR No. 17, dated 24.01.2021 of

Police Station Sector-31. Thereafter, after obtaining report from SHO/PS-31, point wise information was supplied to the appellant.

#### **DECISION:-**

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that appellant had sought information 04 points pertaining to DDR No. 17, Dated 24.01.2021 of PS-31 i.e. videography of, photographs and record relevant to that DDR and CFSL viscera report of deceased Ms. Pooja.

So far as the appeal is concerned, appellant has contended that she had not been provided any information. On the other hand, CPIO/South has asserted that point wise requisite information was already sent to her. Hence, CPIO/South is hereby directed to furnish once again requisite information to the appellant forthwith, free of cost. Accordingly, instant appeal is hereby disposed of.

In case, the appellant is not satisfied with the disposal of appeal, she can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
